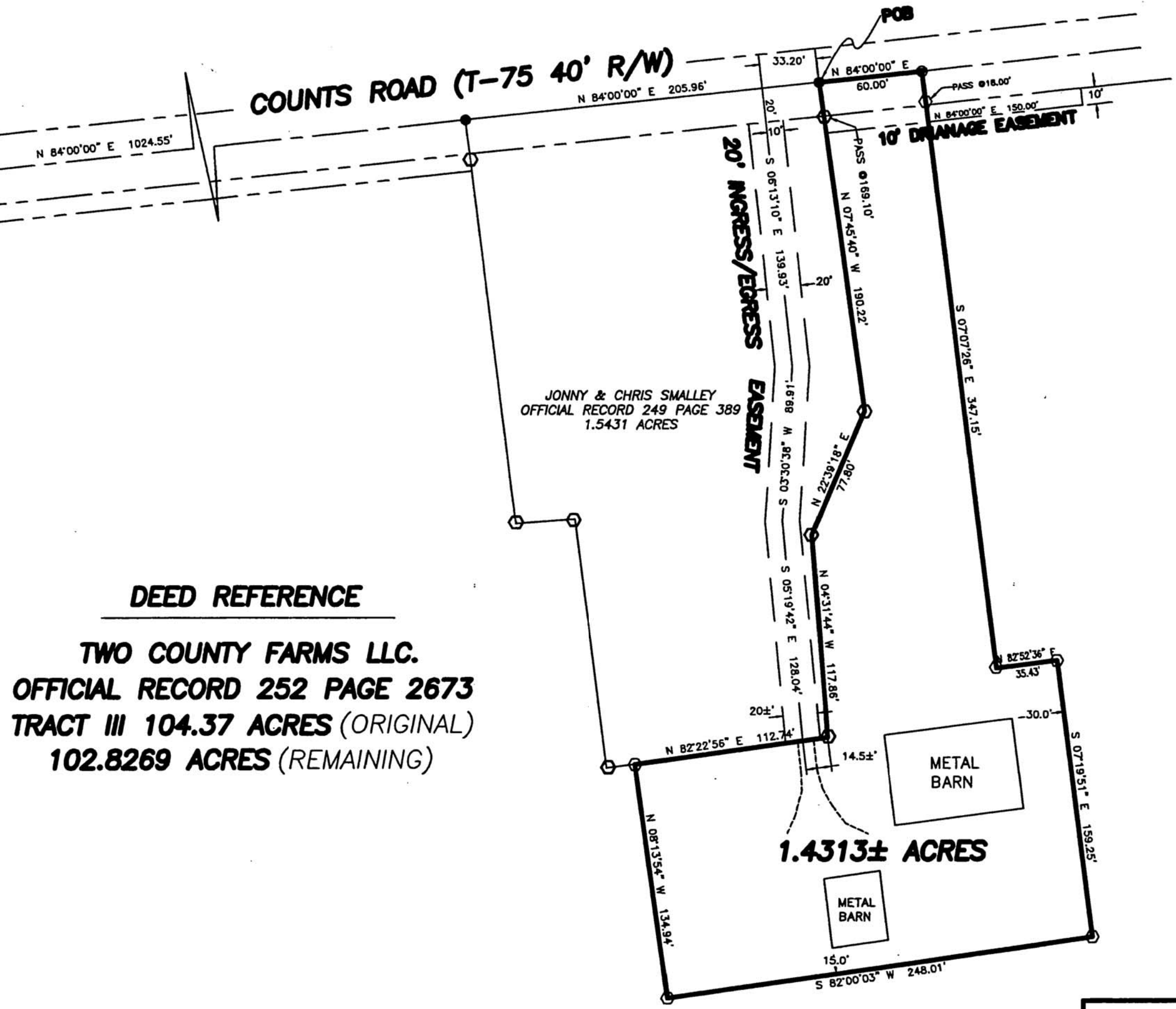


DORN ROAD (T-78 40' R/W)

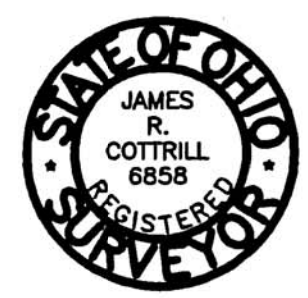

1.4313 Acre Tract  
Surveyed for Jim Gall

The following described 1.4313 acre tract is situated in the State of Ohio, Madison County, Range Township, VMS 4156, being part of a 104.37 original acre tract (102.8269 acres to date) conveyed to Two County Farms, LLC by Official Record 126 page 613, and being more particularly described as follows:

Beginning at a PK nail found at the centerline intersection of Dorn Road (Township Road 76)(40 ft. right-of-way) with the centerline of Counts Road (Township Road 75)(40 ft. right-of-way), said PK nail is also at the north west corner of said 104.37 acre tract;

Thence, with the centerline of said Counts Road, North 84° 00 minutes 00 seconds East a distance of 1230.51 ft. to a railroad spike set in said centerline at the northwest corner of a 1.5431 acre tract conveyed to Jonny and Chris Smalley by Official Record 249 page 389 and **The True Point of Beginning**;

Thence, continuing with said centerline, North 84° 00 minutes 00 seconds East a distance of 60.00 ft. to a mag nail set in said centerline;

Thence, across said 104.37 acre tract the following 5 new courses:

- 1) South 07° 07 minutes 26 seconds East, passing an iron pin and cap set at 18.00 feet, a total distance of 347.15 ft. to an iron pin and cap set
- 2) North 82° 52 minutes 36 seconds East a distance of 35.43 ft. to an iron pin and cap set
- 3) South 07° 19 minutes 51 seconds East a distance of 159.25 ft. to an iron pin and cap set
- 4) South 82° 00 minutes 03 seconds West a distance of 248.01 ft. to an iron pin and cap set
- 5) North 08° 13 minutes 54 seconds West a distance of 134.94 ft. to an iron pin and cap set in the south line of said 1.5431 acre tract

Thence, with said 1.5431 acre tract the following 4 courses:

- 1) North 82° 22 minutes 56 seconds East a distance about 112.74 ft. to an iron pin and cap previously set
- 2) North 04° 31 minutes 44 seconds West a distance of 117.86 ft. to an iron pin and cap previously set
- 3) North 22° 39 minutes 18 seconds East a distance of 77.80 ft. to an iron pin and cap previously set
- 4) North 07° 45 minutes 40 seconds West, passing an iron pin and cap previously set at 169.10 ft., a total distance of 190.22 ft. returning to **The True Point Beginning** containing **1.4313 Acres** more or less.

subject to and with the benefit of a 10 ft. drainage easement, said drainage easement is tangent to and 10 ft. south of the south right-of-way line of Counts Road and extends from the east line of said 1.5431 acre tract 150 ft. eastward along said south right-of-way line to the eastern terminus of said drainage easement and being more particularly shown on plat accompanying this little description.

With the benefit of a 20 ft. ingress/egress easement extending from the south right-of-way line of said Counts Road to the south line of the here-in-above described 1.5431 acre tract and is 10 ft. left and right of the following described centerline:

Beginning at a point in the south right-of-way line of Counts Road, said point bears South 84° 00 minutes 00 seconds West a distance of 33.20 ft. and South 06° 13 minutes 10 seconds East a distance of 20.00 ft. from the northeast corner of said 1.5431 acre tract;

Thence, across said 1.5431 acre tract, with the centerline of an existing gravel driveway, the following 3 courses:

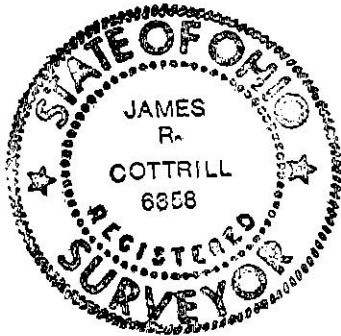
- 1) South 06° 13 minutes 10 seconds East a distance of 139.93 ft.
- 2) South 03° 30 minutes 30 seconds West a distance of 89.91 ft.
- 3) South 05° 19 minutes 42 seconds East a distance a 128.04 ft. to a point in the south line of said 1.5431 acre tract and the southern terminus of said easement


Bearings are based on the centerline of Counts Road (South 84° 00 minutes West) as described in official record 126 page 613.

This deed is subject to and with the benefit of all legal highways, restrictions, easements, limitations, and reservations, of record, if any and to zoning restrictions which have been imposed thereon, if any.

All iron pins set are 5/8 inch diameter rebar with yellow plastic caps stamped "Cottrill 6858."
