The following describe 0.3400 acre tract is situated in the state of Ohio, Madison County, Range Township, VMS 6049, being all of a 0.3 acre tract (21-00157.000) conveyed to Michael P Hann by Official Record 220 page 2511, and being more particularly described as follows:

Commencing at a centerline monument found at the centerline intersection of State Route 323 (50 feet right-of-way) with Danville Road (County Road 8) (44 feet right-of-way);

Thence, with the centerline of said Danville Road the following two courses:

- 1) South 00° 02′ 38″ East a distance of 184.98 feet to a 2 inch diameter iron pipe been (found 2 feet deep)
- 2) South 24° 09′ 10″ East a distance of 308.72 feet to a mag nail set at the Northwest corner of a 2.20 acre tract (21-00056.000) conveyed to Michael E Hann by Official Record 220 page 2511;

Thence, with the North line of said 2.20 acre tract, North 75° 57′ 06″ East a distance of 22.67 feet to an iron pin and cap set in the East right-of-way line of said Danville Road, at the Southeast corner of said 0.3 acre tract and **The True Point of Beginning**;

Thence, with the East right-of-way line of said Danville Rd., **North 24° 09' 10" West** a distance of **101.68 feet** to an iron pin and cap set at the Southwest corner of Range Street (50 feet wide);

Thence, with the South line of Said Range St., **South 87° 42′ 05″ East** a distance of **258.06 feet** to an iron pin and cap set in the West line of a 0.5 acre tract conveyed to Roger G and Evie Eileen Sockman by Official Record 43 page 574, said iron pin and cap is also at the Southeast corner of said Range Street and the Southeast corner of a 0.23 acre tract conveyed to James Hall by Deed Book 248 page 539;

Thence, with the West line of said 0.5 acre tract, **South 00° 01' 23" East** a distance of **28.32 feet** to an iron pin and cap set in the North line of said 2.20 acre tract;

Thence, with the North line of said 2.20 acre tract, **South 75° 57′ 06″ West** a distance of **222.92 feet** returning to **The True Point of Beginning** containing **0.3400 Acres** more or less.

The following describe 2.1867 acre tract is situated in the state of Ohio, Madison County, Range Township, VMS 6049, being all of a 2.20 acre tract (21-00056.000) conveyed to Michael P Hann by Official Record 220 page 2511, and being more particularly described as follows:

Commencing at a centerline monument found at the centerline intersection of State Route 323 (50 feet right-of-way) with Danville Road (County Road 8) (44 feet right-of-way);

Thence, with the centerline of said Danville Road the following two courses:

- 1) South 00° 02′ 38″ East a distance of 184.98 feet to a 2 inch diameter iron pipe been (found 2 feet deep)
- 2) South 24° 09′ 10″ East a distance of 308.72 feet to a mag nail set at the Northwest corner of said 2.20 acre tract and **The True Point of Beginning**;

Thence, with the North line of said 2.20 acre tract, **North 75° 57′ 06″ East**, passing an iron pin and cap set at the Southwest corner of a 0.3 acre tract conveyed to Michael P Hann by Official Record 220 page 2511 at 22.67 feet, a total distance of **245.27 feet** to an iron pin and cap set at the Southwest corner of a 0.5 acre tract conveyed to Roger G and Evie Eileen Sockman by Official Record 43 page 574;

Thence, with the South line of said 0.5 acre tract, **North 75° 57' 06" East** a distance of **271.71 feet** to an iron pin and cap set in the West line of a 1.85 acre tract conveyed to Robert D and Jann Morehead by Official Record 275 page 253;

Thence, with the West line of said 1.85 acre tract, **South 00° 01' 23" East**, passing an iron pin and cap set at 200.53 feet, a total distance of **207.53 feet** to a very large Hedge Apple tree found in the North line of an 11.95 acre tract conveyed to Madison County Commissioners by Official Record 108 page 345;
