The **True Place of Beginning** being a Mag nail set, being on the Centerline of State Route 56 (60 feet wide) as depicted upon sheet 17 of 30 of the "STATE OF OHIO DEPARTMENT OF HIGHWAYS - RIGHT OF WAY MAP of LONDON CIRCLEVILLE ROAD, SH 243, dated 1932, and being at the southwest corner of said 134 acre tract of land, being the southeast corner of a 20 acre tract of land owned by Brooks F. Beery II, and Jane E. Beery, of record in Deed Record Volume 248, Page 2206, and being in a northerly line of a 184.289 acre tract of land owned by Patricia A. 



Said bearing being determined by GPS observations and values as provided by the Government of the United States of America, through the Department of National Geodetic Survey, and is based upon the Ohio South Zone State Plane Coordinate System.
