The following described 1.2158 acre tract is situated in the State of Ohio, Madison County, Monroe Township, VMS 5606, being part of a 20.001 acre tract (11-00014.008) conveyed to Robert J and Donna J Johnson by Official Record 249 page 1206, and being more particularly described as follows:

Commencing at a centerline monument found at the intersection of the centerline of State Route 38 with Josiah - Morris Road (County Road 126)(45 feet right-of-way);

Thence, with the centerline of said Josiah - Morris Road, the following 3 courses:

- 1) North 86° 36' 15" East a distance of 967.20 feet to a 3/4 inch diameter iron pin found 8 inches deep
- 2) North 80° 03' 57" East a distance of 1459.21 feet to an iron pipe found
- 3) North 79° 58' 29" East a distance of 660.06 feet to a mag nail found at the southeast corner of said 20.001 acre tract also being the southwest corner of a 40.538 acre tract conveyed to Robert J and Donna J Johnson by Official Record 249 page 1206;

Thence, with the line between said 20.001 and said 40.538 acre tracts, North 02° 32' 32" West, passing a 3/4 inch diameter iron pipe and yellow plastic cap stamped "Ohio Geomatics" found at 22.62 feet, also passing an iron pin and cap set at 1436.01 feet, a total distance of 1550.25 feet to a 3/4 inch diameter iron pipe and yellow plastic cap stamped "Ohio Geomatics" found at **The True Point of Beginning**;

Thence, with the line between said 20.001 and said 40.538 acre tracts, **South 02° 32' 32" East** a distance of **114.24 feet** to an iron pin and cap set;

Thence, across said 20.001 acre tract, the following 2 new courses:

- 1) **South 89° 04' 46" West** a distance of **195.98 feet** to an iron pin and cap set
- 2) **North 02° 26' 31" West** a distance of **421.03 feet** to an iron pin and cap set in the line between said 20.001 and said 40.538 acre tracts;

Thence, with the line between said 20.001 and said 40.538 acre tracts, the following 3 courses:

- 1) **North 87° 26' 47" East** a distance of **99.35 feet** to a 3/4 inch diameter iron pipe and yellow plastic cap stamped "Ohio Geomatics" found
- 2) **South 02° 33' 43" East** a distance of **312.40 feet** to a point inside a building
- 3) **North 87° 26' 09" East** a distance of **95.71 feet** returning to **The True Point of Beginning** containing **1.2158 Acres** more or less.

The hereinabove described 1.2158 acre tract is to become part of and contingent to said 40.538 acre tract.

Commencing at a centerline monument found at the intersection of the centerline of State Route 38 with Josiah - Morris Road (County Road 126)(45 feet right-of-way);

Thence, with the centerline of said Josiah - Morris Road, the following 3 courses:

- 1) North 86° 36' 15" East a distance of 967.20 feet to a 3/4 inch diameter iron pin found 8 inches deep
- 2) North 80° 03' 57" East a distance of 1459.21 feet to an iron pipe found
- 3) North 79° 58' 29" East a distance of 660.06 feet to a mag nail found at the southeast corner of said 20.001 acre tract also being the southwest corner of a 40.538 acre tract conveyed to Robert J and Donna J Johnson by Official Record 249 page 1206;

Thence, with the line between said 20.001 and said 40.538 acre tracts, the following 4 courses:

- 1) North 02° 32' 32" West, passing a 3/4 inch diameter iron pipe and yellow plastic cap stamped "Ohio Geomatics" found at 22.62 feet, also passing an iron pin and cap set at 1436.01 feet, a total distance of 1550.25 feet to a 3/4 inch diameter iron pipe and yellow plastic cap stamped "Ohio Geomatics" found
- 2) South 87° 26' 09" West a distance of 95.71 feet to a point inside a building
- 3) North 02° 33' 43" West a distance of 312.40 feet to a 3/4 inch diameter iron pipe and yellow plastic cap stamped "Ohio Geomatics" found
- 4) South 87° 26' 47" West a distance of 99.35 feet to an iron pin and cap set at **The True Point of Beginning:**

Thence, with the line between said 20.001 and said 40.538 acre tracts, **South 87° 26' 47" West** a distance of **310.26 feet** to a 3/4 inch diameter iron pipe and yellow plastic cap stamped "Ohio Geomatics" found at the northwest corner of said 20.001 acre tract and in the east line of a 138.25 acre tract conveyed to Sandra Lee Pace by Official Record 237 page 1902, said pipe is also in the line between said VMS 5606 and 10700;

Thence, with the east line of said 138.25 acre tract and said VMS line, the following two courses:

- 1) **North 05° 46' 11" East** a distance of **64.70 feet** to a 1 1/2 inch diameter metal fence post found
- 2) **North 08° 46' 42" West** a distance of **111.95 feet** to an iron pin and cap set

Thence, across said 40.538 acre tract, the following 2 new courses:

- 1) **North 87° 26' 47" East** a distance of **313.37 feet** to an iron pin and cap set
- 2) **South 02° 26' 31" East** a distance of **175.31 feet** returning to **The True Point of Beginning** containing 1.2340 acres more or less.
