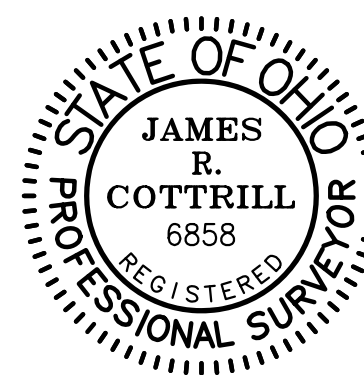

4.2614 Acre Tract

Surveyed for Dorothy Richmond

The following described 4.2614 acre tract is situated in the State of Ohio, Madison County, City of London, VMS 6324, being all that remains of a 0.459 acre tract (31-02311.000)(13.617 original acres, parcel one), all that remains of a 3.87 acre tract (31-02311.000)(6.83 original acres, parcel two), and all the remains of a 0.027 acre tract (31-02311.000)(0.08 original acres, parcel three) all three tracts conveyed to Dorothy M Richmond by Official Record 232 page 528, and being more particularly described as follows:

Commencing at the centerline intersection of E. High Street (width varies)(State Route 142) with Richmond Avenue (60 feet right-of-way);

Thence, with the centerline of said E. High Street, North 67° 54' 13" East a distance of 268.84 feet to a point in said centerline;

Thence, North 22° 05' 47" West a distance of 35.00 feet to a 3/4 inch diameter rebar found in the north line of said E. High Street and at the southeast corner of a 0.6668 acre tract conveyed to Michael S. Turner by Official Record 288 page 1510 and **The True Point of Beginning;**

Thence, with the east line of said 0.6668 acre tract, **North 21° 15' 47" West** a distance of **244.60 feet** to a 3/4 inch diameter iron pipe found corner to a 7.996 acre tract conveyed to Traci Arnold-Tate by Official Record 236 page 406;

Thence, with said 7.996 acre tract the following 8 courses:

- 1) **North 07° 18' 06" West** a distance of **167.75 feet** to a 5/8 inch diameter rebar found
- 2) **North 00° 27' 54" West** a distance of **90.71 feet** to a 3/4 inch diameter iron pipe found
- 3) **South 89° 56' 35" East** a distance of **125.64 feet** to a 5/8 inch diameter rebar and red plastic cap stamped "S.A. England #S-7452" found
- 4) **North 01° 38' 21" East** a distance of **47.68 feet** to a 5/8 inch diameter rebar and red plastic cap stamped "S. A. England #S-7452" found
- 5) **South 85° 16' 31" East** a distance of **67.63 feet** to a 3/4 inch diameter iron pipe found
- 6) **North 06° 57' 17" East** a distance of **76.52 feet** to a 3/4 inch diameter iron pipe found
- 7) **South 82° 45' 30" East** a distance of **138.17 feet** to a 5/8 inch diameter rebar and red plastic cap stamped "S.A. England #S-7452" found
- 8) **South 15° 14' 08" East** a distance of **300.07 feet** to a 5/8 inch diameter rebar and red plastic cap unreadable found at the northwest corner of a 0.493 acre tract conveyed to Harry R Miller and Sarah E Hankins by Official Record 317 page 2208;

Thence, with the west line of said 0.493 acre tract, **South 13° 51' 50" East** a distance of **159.76 feet** to a 5/8 inch diameter rebar found in the north line of said E. High Street;

Thence, with the north line of said E. High Street, **South 67° 54' 13" West** a distance of **374.64 feet** returning to **The True Point of Beginning** containing **4.2614 Acres** more or less, of which 0.3920 acres more or less is all the remains of said 0.459 acre tract, 3.8497 acres more or less is all that remains of said 3.87 acre tract, 0.0197 acres more or less is all the remains of said 0.027 acre tract.

Bearings are based on a GPS observation on October 26, 2016, WGS 1984 Geodetic North.
