

LEGAL DEED DESCRIPTION C & M TROYER 0.139 ACRE

Real estate situated in the Village of Plain City; Darby Township of Madison County, Ohio; in the Virginia Military Survey number 7758-7830; being a more particular description of the 0.1507 acre tract of C & M Troyer (Deed Record 274, page 938 & P.N. 04-00044.000); and being further bounded and described as follows:

Beginning at an iron pipe found at the intersection of the south right-of-way line of Jackson Street (30' R/W) and the east right-of-way line of South Chillicothe Street (60' R/W), being the TRUE POINT OF BEGINNING.

Thence North 23 deg.-12'-48" West (assumed bearing), 47.59 feet along said east right-of-way line of South Chillicothe Street (passing over the north right-of-way line of said Jackson Street at 33.55 feet) to a point at the southwesterly corner of the 0.115 acre tract of Charles W. Bishop IV and Robyn L. Bishop (Official Record 314, page 2499 & P.N. 04-00049.000). Said point is witnessed by a mag nail found which bears: (North 89 deg.-30'-01" West, 9.92 feet).

Thence South 89 deg.-30'-01" East, 94.32 feet along the southerly line of said 0.115 acre tract and the southerly line of the 0.543 acre tract also of Charles W. Bishop IV and Robyn L. Bishop (Official Record 314, page 2501 & P.N. 04-00048.000) to an iron pipe found on the northwesterly corner of the 0.1807 acre tract of Christopher M. Carloni (Official Record 319, page 837 & P.N. 04-00044.001).

Thence South 07 deg.-35'-45" West, 95.81 feet along the west line of said 0.1807 acre tract (passing over the north right-of-way line of said Jackson Street at 17.32 feet and an iron pipe found on the south line at 47.40 feet) to an iron pipe found at the northeasterly corner of a 0.039 acre tract surveyed this date which is currently part of the 0.212 acre tract of Ron Winn (Official Record 145, page 789 & P.N. 04-00668.007).

Thence North 69 deg.-00'-30" West, 52.01 feet along the northerly line of said 0.039 acre tract to an iron pipe found on said east right-of-way line of South Chillicothe Street.

Thence North 23 deg.-12'-48" West, 36.37 feet along said east right-of-way line to the TRUE POINT OF BEGINNING.

Bearing was assumed from Plat 4-96. The tract as described from an actual field survey performed on or about September 20, 2018, by Registered Surveyor Joseph P. Priday (S-7277), contains **0.139 acre**, more or less, (of which 0.054 acre is within said Jackson Street right-of-way), subject to all previous easements and rights-of-way of record. All iron rods set are 5/8" x 30" with plastic I.D. caps. The plat of survey is on file in the map room of the Madison County Engineer.

LEGAL DEED DESCRIPTION RON WINN 0.039 ACRE

Real estate situated in the Village of Plain City; Darby Township of Madison County, Ohio; in the Virginia Military Survey number 7758-7830; being part of the 0.212 acre tract of Ron Winn (Official Record 145, page 789 & P.N. 04-00668.007); and being further bounded and described as follows:

Beginning for reference at an iron pipe found at the intersection of the south right-of-way line of Jackson Street (30' R/W) and the east right-of-way line of South Chillicothe Street (60' R/W).

Thence South 23 deg.-12'-48" East (assumed bearing), 36.37 feet along said east right-of-way line of South Chillicothe Street to an iron pipe found at the southwesterly corner of the 0.1507 acre tract (0.139 acre as surveyed this date) of C & M Troyer (Deed Record 274, page 938 & P.N. 04-00044.000), being the TRUE POINT OF BEGINNING.

Thence South 69 deg.-00'-30" East, 52.01 feet along the southerly line of said 0.1507 (0.139) acre tract to an iron pipe found on the northwesterly corner of the 0.019 acre tract of Christopher M. Carloni (Official Record 319, page 837 & P.N. 04-00044.001).

Thence South 07 deg.-28'-32" West, 11.60 feet along the west line of said 0.019 acre tract to an iron pipe found at the southwesterly corner of said tract.

Thence South 23 deg.-12'-48" East, 22.27 feet entering said 0.212 acre tract to an iron rod set.

Thence South 66 deg.-47'-12" West, 31.36 feet to an iron rod set on said east right-of-way line of South Chillicothe Street.

Thence North 23 deg.-12'-48" West, 68.51 feet along said east right-of-way line to the TRUE POINT OF BEGINNING.
