2. South 40° 23' 30" West a distance of 848.50 feet to a railroad spike set on the southeasterly corner of a 20.762 acre tract (Official Record 209, Page 1297);

Thence leaving the center of Nioga-Toops Road and along the property line of the 20.762 acre tract the following three (3) courses:

1. North 36° 43' 40" West, passing a 3/4" iron pipe found at 30.83 feet, going a total distance of 797.58 feet to a 5/8" iron pin with a plastic identification cap set,

North 40° 23' 51" East a distance of 800.31 feet to a 3/4" iron pipe found, and;
North 54° 51' 51" East a distance of 204.69 feet to a point on the northwesterly corner of a 5.15




EXHIBIT "A" (17.029 ACRE TRACT)

Being a tract of land that is now or formerly in the name of Danny H. and Linda S. Scott, Co-Trustees of the Danny H. and Linda S. Scott, Family Trust Agreement as recorded in Official Record 302, Page 2681 of the Madison County Recorder's Office and is situated in Virginia Military Survey (V.M.S.) 5766, Fairfield Township, Madison County, State of Ohio and being more particularly described as follows:

Beginning for reference on a set railroad spike located at the intersection of the MADISON-PICKAWAY COUNTY LINE and the center of Nioga-Toops Road (County Road 60 / 33' R-OW);

Thence leaving the MADISON-PICKAWAY COUNTY LINE and along the center of Nioga-Toops Road the following two (2) courses:

- 1. South 46° 35' 26" West a distance of 262.34 feet to a iron spike found, and;
- 2. South 54° 52' 03" West a distance of 807.72 feet to a railroad spike set being the **principal place of beginning** of the tract herein described;

Thence continuing along the center of Nioga-Toops Road the following two (2) courses:

- 1. South 54° 52' 03" West, passing a iron spike found at 51.36 feet, going a total distance of 52.12 feet to a iron spike set, and;
- 2. South 40° 23' 30" West a distance of 848.50 feet to a railroad spike set on the southeasterly corner of a 20.762 acre tract (Official Record 209, Page 1297);

Thence leaving the center of Nioga-Toops Road and along the property line of the 20.762 acre tract the following three (3) courses:

- 1. North 36° 43' 40" West, passing a 3/4" iron pipe found at 30.83 feet, going a total distance of 797.58 feet to a 5/8" iron pin with a plastic identification cap set,
- 2. North 40° 23' 51" East a distance of 800.31 feet to a 3/4" iron pipe found, and:
- 3. North 54° 51' 51" East a distance of 204.69 feet to a point on the northwesterly corner of a 5.15 acre tract (Official Record 191, Page 1299);

Thence along the property line of the 5.15 acre tract, South 29° 02' 45" East, passing a 5/8" iron pin with a plastic identification cap set at 15.00 feet, passing a 3/4" iron pipe found at 759.46 feet, going a total distance of 789.60 feet to the **principal place of beginning**, containing **17.029 acres** more or less and being subject to the right of way of Nioga-Toops Road (County Road 60 / 33' R-O-W) and all other legal easements of record.

Being all of Auditor's Parcel 07-00068.000, a 17.043 acre tract (17.029 acres as surveyed).
