

23.176 ACRES

Situated in the State of Ohio, County of Madison, Village of Plain City, in Virginia Military Survey Numbers 5125 and 8305, being part of that 136.351 acre tract of land conveyed to Bruce A. Ratcliff and Marilyn G. Ratcliff by deeds of record in Official Record 289, Page 199, Official Record 289, Page 202 and Official Record 289, Page 205, also being Auditor's Parcel Number 04-00824.00 (all references refer to the records of the Recorder's Office, Madison County, Ohio), and more particularly bounded and described as follows:

BEGINNING at an iron pin set at the southeasterly corner of Reserve "E" of the subdivision entitled "Darby Fields Section 2", of record in Plat Book B, Page 398, in the northerly line of that tract conveyed to Philip Jay Gingerich and Ruth Ann Gingerich by deed of record in Official Record 306, Page 2185;

Thence North 02° 17' 17" East, with the easterly line of said Reserve "E", a distance of 49.60 feet to an iron pin set;

Thence North 49° 09' 16" West, with the easterly line of said Reserve "E", a distance of 154.50 feet to an iron pin set at the southwesterly corner of Lot 12 of the subdivision entitled "Darby Fields Section 1", of record in Plat Book B, Page 395;

Thence North 64° 18' 14" East, with the southerly line of said Lot 12, a distance of 143.99 feet to an iron pin set at the northeasterly corner thereof, a southwesterly corner of that tract conveyed to M/I Homes of Central Ohio, LLC by deed of record in Official Record 329, Page 2327;

Thence with the boundary of said M/I tract the following courses and distances:

With the arc of a curve to the left, having a central angle of 62° 01' 10", a radius of 174.00 feet, an arc length of 188.35 feet, a chord bearing of South 56° 42' 21" East and chord distance of 179.28 feet to an iron pin set;

South 87° 42' 56" East, a distance of 187.00 feet to an iron pin set;

North 02° 17' 04" East, a distance of 159.00 feet to an iron pin set; and

South 87° 42' 56" East, a distance of 450.00 feet to an iron pin set in the westerly line of Reserve "B" of said "Darby Fields Section 1";

Thence with the boundary of said Reserve "B" the following courses and distances;

South 02° 17' 04" West, a distance of 105.00 feet to an iron pin set;

South 87° 42' 56" East, a distance of 77.00 feet to an iron pin set at a point of curvature to the left; and

With the arc of said curve, having a central angle of 125° 46' 14", a radius of 120.00 feet, an arc length of 263.41 feet, a chord bearing of North 29° 23' 57" East and chord distance of 213.62 feet to an iron pin set;

Thence North 56° 30' 50" East, partly with the boundary of said "Darby Fields Section 1" and partly with the boundary of said M/I tract, a distance of 416.44 feet to an iron pin set in the easterly right of way line of Plain City-Georgesville Road;

Thence South 33° 53' 04" East, with said easterly right of way line, a distance of 332.21 feet to an iron pin set;

Thence South 31° 53' 36" East, with said easterly right of way line, a distance of 801.57 feet to an iron pin set;

Thence crossing said Ratcliff tract the following courses and distances:

South 58° 06' 24" West, a distance of 567.34 feet to an iron pin set;

South 89° 42' 53" West, a distance of 258.67 feet to an iron pin set; and

North 57° 22' 58" West, a distance of 123.16 feet to a 5/8" iron rebar found at a corner of Gingerich tract;

Thence North 21° 16' 42" West, with an easterly line of said Gingerich tract, a distance of 644.44 feet to a 12" x 12" concrete post found at a corner thereof;

Thence North 87° 42' 43" West, with the northerly line of said Gingerich tract, a distance of 863.93 feet to the POINT OF BEGINNING, containing 23.176 acres of land, more or less, of which 1.301 acre fall within the presently occupied right of way of Plain City-Georgesville Road.
