

SURVEY DESCRIPTION 40.436 Acres February 28, 2019

The following described 40.436 acre tract is situated in the State of Ohio, County of Madison, Township of Darby, V.M.S. 3240, being all of Valentine Yutzy's 40.0939 acre Tract III, which is all of the remainder of an original 59.043 acre Parcel No. 1 (Madison County Parcel Number 02-00341.000) and all of the remainder of an original 2.107 acre Parcel No. 2 (Madison County Parcel Number 02-00339.000), both being described in Official Record 338, page 1793, and said 40.436 acre tract being more particularly described as follows:

Beginning for reference at a railroad spike found at the intersection of the centerline of Plain City-Georgesville Road (C.R. 7, 50 feet right of way) with the south line of Darby Township and the north line of Canaan Township;

Thence North 2°06'59" West 405.61 feet, following the centerline of Plain City-Georgesville Road, to a railroad spike found;

Thence North 2°13'33" West 248.96 feet, following the centerline of Plain City-Georgesville Road, to a railroad spike found;

Thence North 2°24'00" West 62.81 feet, following the centerline of Plain City-Georgesville Road, to a magnetic nail set at a southwest corner of the remainder of said original 59.043 acre tract and at the northwest corner of Timothy R. Wengerd's 1.0001 acre tract described in Official Record 290, page 1129, said nail marking the *place of beginning*;

Thence *North 2°24'00" West 1039.85 feet*, following the centerline of Plain City-Georgesville Road and a west line of said original 59.043 acre tract, to a railroad spike found;

Thence *North 3°23'02" West 253.75 feet*, following the centerline of Plain City-Georgesville Road and a west line of said original 59.043 acre tract, to a railroad spike found;

Thence *North 17°26'47" West 136.17 feet*, following the centerline of Plain City-Georgesville Road and a west line of said original 59.043 acre tract, to a railroad spike found at the southwest corner of Robert L. Andras and Roberta C. Andras' 6.318 acre Parcel No. 2 described in Official Record 99, page 1298;

Thence *North* 76°35'50" *East* 937.42 *feet*, departing from the centerline of Plain City-Georgesville Road, following the north line of said original 59.043 acre tract and the south line of said 6.318 acre tract, passing at 25.08 feet a 1½ inch iron pipe found, passing at 623.89 feet a 1½ inch iron pipe found, and passing at 887.42 feet an iron pin set, to a point at the westerly low water line of Big Darby Creek;

Thence *South 28°49'14" East 25.46 feet*, following an easterly line of said original 59.043 acre tract and the westerly low water line of Big Darby Creek, to a point;

Thence *South 16°17'51" East 122.22 feet*, following an easterly line of said original 59.043 acre tract and the westerly low water line of Big Darby Creek, to a point;

Thence *South 41°03'16" East 63.26 feet*, following an easterly line of said original 59.043 acre tract and the westerly low water line of the Big Darby Creek, to a point, said point bearing North 83°24'15" East 135.75 feet from an iron pin set;

Thence *South 15°54'08" West 178.73 feet*, following an easterly line of said original 59.043 acre tract and the westerly low water line of the Big Darby Creek, to a point bearing South 28°47'10" East 178.34 feet from an iron pin set;

Thence *South 13°40'03" East 101.98 feet*, following an easterly line of said original 59.043 acre tract and the westerly low water line of the Big Darby Creek, to a point;

Thence *South* 7°30'02" *East 200.81 feet*, following an easterly line of said original 59.043 acre tract and the westerly low water line of the Big Darby Creek, to a point bearing North 77°48'04" East 109.02 feet from an iron pin set;

Thence *South 8°22'30" East 230.25 feet*, following an easterly line of said original 59.043 acre tract and the westerly low water line of the Big Darby Creek, to a point;

Thence *South 22°54'12" East 164.95 feet*, following an easterly line of said original 59.043 acre tract and the westerly low water line of the Big Darby Creek, to a point;

Thence **South** 56°00'20" East 98.41 feet, following an easterly line of said original 59.043 acre tract and the westerly low water line of the Big Darby Creek, to a point bearing North 81°01'19" East 227.00 feet from an iron pin set;

Thence **South 17°43'45"** West 83.84 feet, following an easterly line of said original 59.043 acre tract and the westerly low water line of the Big Darby Creek, to a point;

Thence *South 5°38'08" West 69.54 feet*, following an easterly line of said original 59.043 acre tract and the westerly low water line of the Big Darby Creek, to a point;

Thence *South 10°07'49" West 192.47 feet*, following an easterly line of said original 59.043 acre tract and the westerly low water line of the Big Darby Creek, to a point;

Thence *South 8°31'02" West 89.13 feet*, following an easterly line of said original 59.043 acre tract and the westerly low water line of the Big Darby Creek, to a point;

Thence South 51°35'36" West 244.78 feet, following an easterly line of said original 59.043 acre tract and the westerly low water line of the Big Darby Creek, to a point bearing South 48°17'55" East 80.00 feet from an iron pin set:

Thence South 30°36'34" West 325.16 feet, following an easterly line of said original 59.043 acre tract and the westerly low water line of the Big Darby Creek, to a point;

Thence South 20°18'50" West 69.67 feet, following an easterly line of said original 59.043 acre tract and the westerly low water line of the Big Darby Creek, to a point at the northeast corner of said original 2.107 acre tract;

Thence South 2°19'39" East 151.61 feet, following an east line of said original 59.043 acre tract, the westerly low water line of the Big Darby Creek, and the east line of said original 2.107 acre tract, to a point at the northeast corner of the remainder of James I. Martin's original 6.209 acre Parcel No. 1 described in Official Record 99, page 195;

Thence North 83°53'33" West 421.74 feet, following the south line of said original 2.107 acre tract and the north line of said 6.209 acre tract, passing at 82.49 feet a 5/8 inch iron pin found with cap marked PS 5966", to a magnetic nail set at the southeast corner of Clifford A. Kemmerling and Anna M. Borghese's 1.0000 acre tract described in Official Record 239, page 693;

Thence North 2°13'33" West 463.19 feet, following west line of the remainder of said original 2.107 acre tract, the west line of the remainder of said original 59.043 acre tract, and the east line of said 1.0000 acre tract, passing at 231.79 feet a 3/4 inch iron pipe found at the southeast corner of said 1.0001 acre tract, thereafter following the east line of said 1.0001 acre tract, to a 3/4 inch iron pipe found;

Thence North 83°50'07" West 190.26 feet, following a south line of the remainder of said original 59.043 acre tract and the north line of said 1.0001 acre tract, passing at 165.36 feet a 3/4 inch iron pipe found, to the place of beginning, containing 40.436 acres, more or less, and being subject to all valid easements and restrictions of record.

The above description was prepared from a field survey made under the supervision of Paul R. Clapsaddle, Registered Surveyor #6140, during the month of February 2019. Bearings indicated herein are based upon NAD 83 (2011) Ohio State Plane Coordinates (South Zone) as derived from GPS observations. Iron pins set are 5/8 inch by 30 inch reinforcing rods with caps marked "CLAPSADDLE RS 6140". appaddl
