



LOCATION MAP



Commencing at a monument box found at an angle point in State Route 56 (right-of-way width varies) and at the centerline intersection with Big Plain-Circleville Road (County Road 4, 50 feet right-of-way);

Thence, with the centerline of State Route 56, South $11^{\circ} 36' 12''$ East a distance of 2566.70 feet to an iron pin found at a point of intersection in the State Route 56;

Thence, with the original centerline of State Route 56 with the following three courses:

- 1) South $42^{\circ} 53' 26''$ East a distance of 467.57 feet to a point;
- 2) South $42^{\circ} 37' 24''$ East a distance of 640.15 feet to a point;
- 3) South $43^{\circ} 19' 47''$ East a distance of 571.24 feet to the East corner of a 5.000 acre tract conveyed to Charles A Farmer and Carla A Farmer by Official Record 282 page 2272, the North corner of said 10.0015 acre tract and being the **True Point of Beginning**;

Thence, continuing with the original centerline of State Route 56, **South $43^{\circ} 19' 47''$ East** a distance of **200.00 feet** to a point;

Thence, across said 10.0015 acre tract with the following eight new courses:

- 1) **South $46^{\circ} 40' 27''$ West** a distance of **55.00 feet** to an iron pin and cap set;
- 2) **North $43^{\circ} 19' 33''$ West** a distance of **47.53 feet** to an iron pin and cap set;
- 3) **South $58^{\circ} 03' 13''$ West** a distance of **138.02 feet** to a mag nail set;
- 4) **South $44^{\circ} 45' 31''$ West** a distance of **93.62 feet** to an iron pin and cap set;

Thence, with the centerline of State Route 56, South 11° 36' 12" East a distance of 2566.70 feet to an iron pin found at a point of intersection in the State Route 56;

Thence, with the original centerline of State Route 56 with the following three courses:

- 2) South 42° 37' 24" East a distance of 640.15 feet to a point;

Thence, with the Northeast line of said 3.000 acre tract, **North 34° 23' 57" West** a distance of **388.61 feet** returning to the **True Point of Beginning**, containing **3.6546 Acres** more or less.
