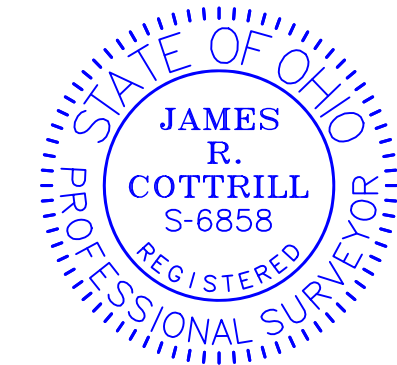

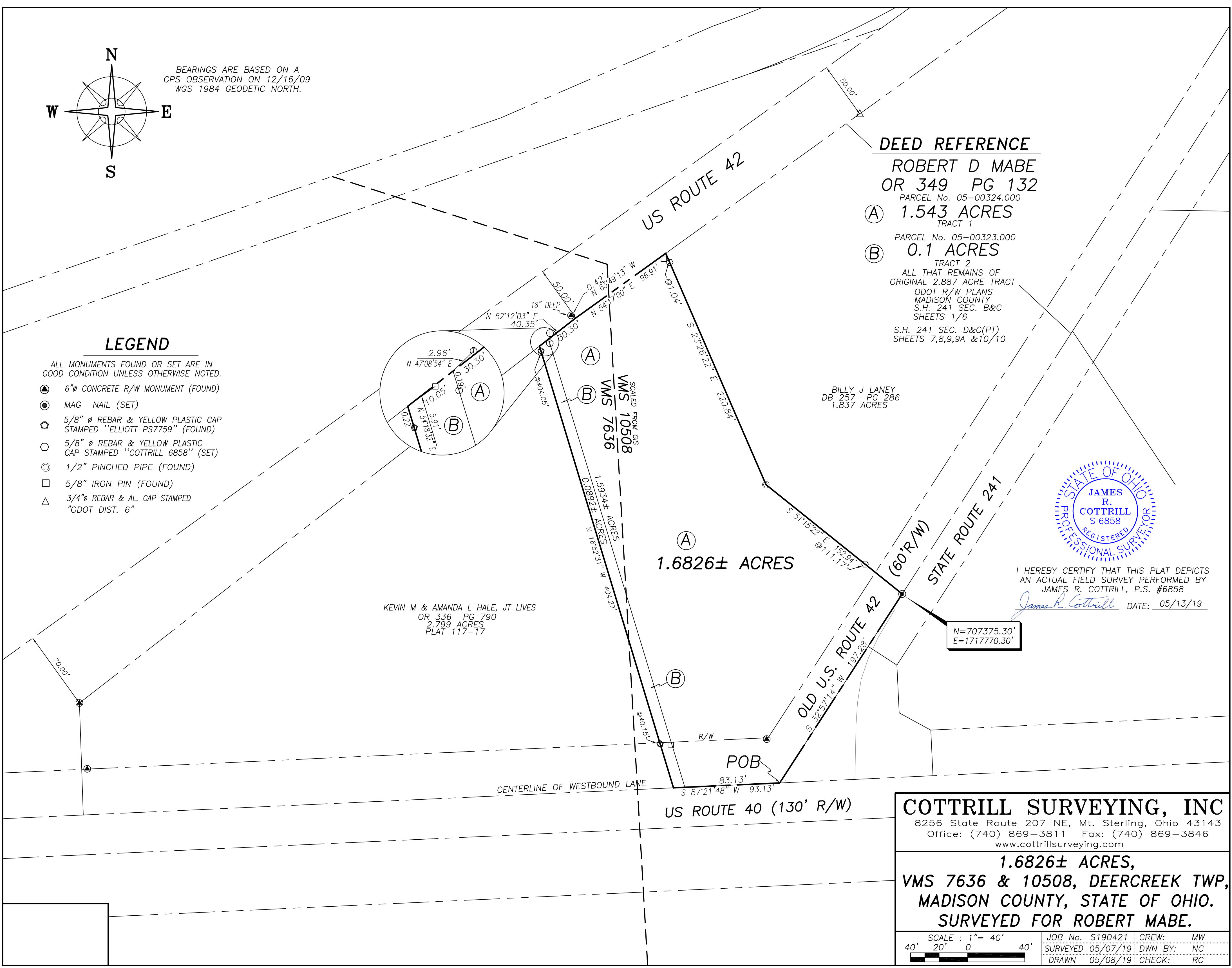

## 1.6826 Acre Tract Surveyed for Robert Mabe

The following described 1.6826 acre tract is situated in the State of Ohio, Madison County, Deercreek Township, VMS 7636 and 10508, being all of a 1.543 acre tract (parcel #05-00324.000, Tract 1) and all of a 0.1 acre tract (parcel #05-00323.000, Tract 2) both tracts conveyed to Robert D Mabe by official record 349 page 132, and being more particularly described as follows:

Beginning at the centerline intersection of the westbound lane of US 40 (130 feet right-of-way) with the old US Route 42 / State Route 241 (60 feet right-of-way), said intersection is also the southeast corner of said 1.543 acre tract;

Thence, with the centerline of said westbound Lane, US 40, **South 87° 21' 48" West**, passing the southeast corner of said 0.1 acre tract at 83.13 feet, a total distance of **93.13 feet** to the southeast corner of a 2.799 acre tract conveyed to Kevin M and Amanda L Hale, joint lives by Official Record 336 page 790;

Thence, with the east line of said 2.799 acre tract, **North 16° 52' 31" West**, passing a 5/8 inch diameter rebar and yellow plastic caps stamped "Elliott PS 7759" found at 40.15 and 404.05 feet, a total distance of **404.27 feet** to the southeast line of said State Route 42;

Thence, with the southeast line of said US Route 42, the following two courses:

- 1) **North 52° 12' 03" East**, passing the northwest corner of said 1.543 acre tract at 10.05 feet, a total distance of **40.35 feet** to an angle point in said line, a damaged 6 inch diameter concrete right-of-way monument found 18 inches deep bears North 63° 49' 13" West a distance of 0.42 feet
- 2) **North 54° 17' 00" East** a distance of **96.91 feet** to the northwest corner of a 1.837 acre tract conveyed to Billie J Laney by Deed Book 257 page 286;

Thence, with said 1.837 acre tract the following two courses:

- 1) **South 23° 26' 22" East**, passing an iron pin and cap set at 1.04 feet, a total distance of **220.84 feet** to a 1/2 inch diameter pinched iron pipe found
- 2) **South 51° 15' 22" East**, passing an iron pin and cap set at 111.17 feet, a total distance of **152.94 feet** to a mag nail set in the centerline of said State Route 241;

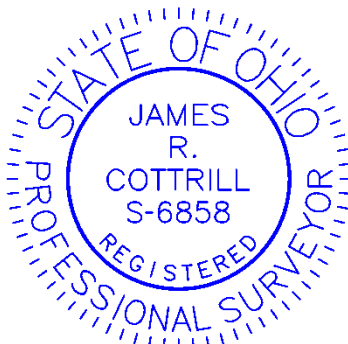
Thence, with the centerline of said State Route 241, **South 32° 57' 14" West** a distance of **197.28 feet** returning to the point of beginning containing **1.6826 Acres** more or less, of which 1.5934 acres more or less is all of said 1.543 acre tract and 0.0892 acres more or less is all of said 0.1 acre tract.


Bearings are based on a GPS observation on December 16, 2009, WGS 1984 Geodetic North.

All iron pins set are 5/8-inch diameter rebar with yellow plastic cap stamped "Cottrill 6858."
