
Plat of Survey for

Description of 0.146 Acre Tract

Situate in the State of Ohio, Madison County, Village of West Jefferson and being a part of VMS 2836 all of a 0.147 acre tract as described in the deed to B & K Remodelers LLC recorded in OR 254 Pg.865 (Auditors Parcel # 10-00153) and being more particularly described as follows:

Beginning at a "mag nail" set at the southeast corner of Lot 18 of the Fellows Subdivision (PB 1 Pg.380) and in the northerly line of Fellows Ave. (50' R/W);

thence, along the east line of said Lot 18 (Fellows Subdivision) as described in the deed to Raymond L. & Sandra O. Boucher (DB 195 Pg. 211) North 33°49'33" West, a distance of 111.48 feet to a 5/8" rebar found in the southerly line of a 0.565 acre tract as described in the deed to Herman E. Stanley (DB 273 Pg.67);

thence, along the southerly line of said 0.565 acre tract North 56°14'00" East, a distance of 57.25 feet to an iron pin set at the northwest corner of a 0.155 acre tract as described in the deed to Paulette Rose (OR 139 Pg. 1354);

thence, along the west line of said 0.115 acre tract South 33°49'00" East, a distance of 110.00 feet to a 5/8" rebar found in the northerly line of Fellows Ave. and the southwest corner of said 0.115 acre tract;

thence, along the northerly line of Fellows Ave., South 54°45'00" West, a distance of 57.25 feet to the Point of Beginning and containing 0.146 ACRES, more or less.
