

SURVEY FOR THE ADAMS FAMILY ESTATE 111.748 Acres August 15, 2019

The following described 111.748 acre tract is situated in the State of Ohio, Union County and Union Township, Champaign County and Goshen Township, Madison County and Pike Township, V.M.S. 4735, V.M.S. 7142, V.M.S. 6312, V.M.S. 4942, V.M.S. 7737, and V.M.S. 9217, being part of Linda L. Geer and Ginger A. Cook, Trustees' 153.676 acre tract described in Champaign County Official Record 563, page 1026, in Union County Instrument Number 201902210001235, and in Madison County Official Record 347, page 1172, and being all of Linda L. Geer and Ginger A. Cook, Trustees' 1.277 acre tract described in Champaign County Official Record 566, page 3619, and said 111.748 acre tract being more particularly described as follows;

Beginning for reference in Union County at a 1 inch iron pin found in a monument box on the centerline of State Route 161 and State Route 4 (variable right of way width) and at the south terminus of the centerline of Champaign County Line Road (Township Road 77, 50 feet wide, planned 60 feet wide);

Thence South 59°44'38" West 301.01 feet, following the centerline of State Route 161 and State Route 4, to a magnetic spike set at the north corner of said 153.676 acre tract and at a northwest corner of David A. Shiffer and Bridget M. Shiffer's 118.44 acre tract described in Union County Official Record 178, page 1, said magnetic spike marking the *place of beginning*;

Thence **South 36°28'48" East 326.68 feet**, departing from the centerline of State Route 161 and State Route 4, following a northeast line of said 153.676 acre tract and a southwest line of said 118.44 acre tract, passing at 44.75 feet an iron pin set, to an iron pin set;

Thence *North 87°31'43" East 226.37 feet*, following a north line of said 153.676 acre tract and a south line of said 118.44 acre tract, to an iron pin set;

Thence **South 30°47'38"** East 548.32 feet, following a northeast line of said 153.676 acre tract and a southwest line of said 118.44 acre tract, passing at 538.32 feet an iron pin set, to a point in the center of a 36 inch osage orange tree;

Thence **South 48°17'51" West 302.78 feet**, following a southeast line of said 153.676 acre tract and a northwest line of said 118.44 acre tract, passing at 10.00 feet an iron pin set, to an iron pin set;

Thence *South 06°45'04" East 2445.75 feet*, following the east line of said 153.676 acre tract and a west line of said 118.44 acre tract, departing from V.M.S. 4735, crossing an east corner of V.M.S. 7142, crossing a west corner of V.M.S. 6312, and again entering V.M.S. 7142, to an iron pin set in a northwest line of The Dayton Power and Light Company's 115 acre tract described in Union County Deed Record 209, page 414, in Madison County Deed Record 160, page 699, and in Champaign County Deed Record 185, page 196, said iron pin being on the south line of Union County and on the north line of Madison County;

Thence *South 35°24'07" West 2544.49 feet*, following the southeast line of said 153.676 acre tract and a northwest line of said 115 acre tract, passing a southeast line of V.M.S. 7142, crossing V.M.S. 4942, and reentering V.M.S. 7142, to an iron pin set in the west line of Madison County and in the east line of Champaign County;

Thence *North 5°51'26" East 40.56 feet*, following a segment of the southeast line of said 153.676 acre tract and a segment of the northwest line of said 115 acre tract, following the west line of Madison County and the east line of Champaign County, to an iron pin set;

Thence *South 35°24'06" West 666.67 feet*, entering Champaign County, following a southeast line of said 153.676 acre tract, the southeast line of said 1.277 acre tract, and following a northwest line of said 115 acre tract, passing the west line of V.M.S. 7142 and entering V.M.S. 9217, to a 5/8 inch iron pin found at the east corner of Buck Eagle Farms LTD's 201.816 acre

tract described in Champaign County Official Record 554, page 131, said iron pin being in the southwest line of V.M.S. 9217 and in the northeast line of V.M.S. 5862;

Thence *North 31°02'01" West 1928.62 feet*, following a southwest line of said 1.277 acre tract, a southwest line of said 153.676 acre tract, the southwest line of V.M.S. 9217, and following the northeast line of said 201.816 acre tract and V.M.S. 5862, to an iron pin set 2.72 feet west of a 6 inch wood corner post found, said iron pin marking the south corner of L. Leroy Blazer Trustee, etal's 103.3563 acre Tract II described in Champaign County Official Record 451, page 2445;

Thence *North* 48°51'52" *East* 2024.04 feet, following a northwest line of said 153.676 acre tract and the southeast line of said 103.3563 acre tract, crossing V.M.S. 9217, crossing V.M.S. 7737, and entering V.M.S. 7142, to a 3 inch angle iron post found;

Thence *North 6°05'51" West 245.92 feet*, following a west line of said 153.676 acre tract and an east line of said 103.3563 acre tract, to an iron pin set;

Thence *North 83°49'45" East 1206.20 feet*, entering said 153.676 acre tract, passing the east line of Champaign County and entering Union County, to an iron pin set;

Thence *North 6°45'04" West 1683.30 feet*, continuing through said 153.676 acre tract, passing a northeast line of V.M.S. 7142, crossing the west corner of V.M.S. 6312, crossing the east corner of V.M.S.7142, and entering V.M.S. 4735, to an iron pin set;

Thence North 48°17'51" East 284.51 feet, continuing through said 153.676 acre tract, to an iron pin set;

Thence *North 30°47'38" West 462.96 feet*, continuing through said 153.676 acre tract, to an iron pin set;

Thence South 87°31'43" West 222.44 feet, continuing through said 153.676 acre tract, to an iron pin set;

Thence *North 36°28'48" West 365.12 feet*, continuing through said 153.676 acre tract, passing at 323.45 feet an iron pin set, to a magnetic spike set in the centerline of State Route 161 and State Route 4;

Thence *North* 59°44'38" *East* 60.35 feet, following the centerline of State Route 161 and State Route 4, and following the northwest line of said 153.676 acre tract to the *place of beginning, containing 111.748 acres*, more or less, and being subject to all valid easements and restrictions of record.

Of the above described 111.748 acre tract, 23.682 acres are in Union County (Parcel No. 32-0008003.0000). Of the above 23.682 acre tract, the following is a breakdown of acreage by V.M.S. and area in the road right of way:

0.060 acre is within the right of way of State Route 161 and State Route 4, 2.185 acres are in V.M.S. 4735, 21.173 acres are in V.M.S. 7142, and 0.324 acre is in V.M.S. 6312.

Of the above described 111.748 acre tract, 30.413 acres are in Madison County (Parcel No. 15-00002.000). Of the above described 30.413 acre tract, the following is a breakdown of acreage by V.M.S.:

24.704 acres are in V.M.S. 7142, and 5.709 acres are in V.M.S. 4942.

Of the above described 111.748 acre tract, 57.653 acres are in Champaign County (Parcel No. C06-03-00-42-00-049-00 and Parcel No. C06-03-00-52-00-028-00). Of the above described 57.653 acre tract, the following is a breakdown of acreage by V.M.S.:

22.914 acres are in V.M.S. 7142, 12.422 acres are in V.M.S. 7737, and 22.317 acres are in V.M.S. 9217.

Of the total 111.748 acres tract, 110.471 acres are part of said 153.676 acre tract, and 1.277 acres are all of said 1.277 acre tract

The following described Ingress and Egress Easement is situated in the State of Ohio, Union County, Union Township, V.M.S. 4735, being over part of Linda L. Geer and Ginger A. Cook, Trustees' 153.676 acre tract described in Union County Instrument Number 201810010007789, and said easement being more particularly described as follows;

Beginning for reference at a 1 inch iron pin found in a monument box on the centerline of State Route 161 and State Route 4 (variable right of way width) and at the south terminus of the centerline of Champaign County Line Road (Township Road 77, 50 feet wide, planned 60 feet wide);

Thence South 59°44'38" West 489.67 feet, following the centerline of State Route 161 and State Route 4, passing at 301.01 feet a magnetic spike set at the north corner of said 153.676 acre tract, thereafter following a northwest line of said 153.676 acre tract, to a point and marking the *place of beginning*;

Thence **South** 6°30'47" West 44.56 feet, departing from the centerline of said road and entering said 153.676 acre tract, to a point;

Thence continuing through said 153.676 acre tract the following 19 courses and distances:

- 19) North 25°13'40" West 47.92 feet to a point.

Thence *North 53°19'14" West 36.75 feet*, continuing through said 153.676 acre tract, to a point on the centerline of State Route 161 and State Route 4 and in the northwest line of said 153.676 acre tract;

Thence *North* 59°44'38" *East* 65.00 feet, following the centerline of State Route 4 and State Route 161 and a northwest line of said 153.676 acre tract, to the *place of beginning*.
