Commencing at a monument box found at the centerline intersection of Gregg Road (County Road 43, 50 feet right-of-way) and State Route 142 (60 feet right-of-way);

Thence, with the centerline of Gregg Road the following 5 courses:

- 1) South 35° 50′ 08″ East, passing a railroad spike found in the north line of a 39.899 acre tract (Railroad) conveyed Pennsylvania Lines, LLC by Deed Book 237 page 255 at 707.17 feet, a total distance of 809.68 feet to a railroad spike found in the south line of said railroad
- 2) South 36° 01′ 10″ East a distance of 1302.42 feet to a ¾″ tee bar and cap found
- 3) South 04° 50′ 25″ West a distance of 1530.74 feet to a ¾″ tee bar and cap found
- 4) South 82° 47′ 41″ East a distance of 2194.27 feet to a Mag nail set at the southeast corner of a 129.053 acre tract conveyed to Phillipi Farms by Official Record 261 page 1629 and the southwest corner of said 163.708 acre tract
- 5) South 82° 47′ 07″ East a distance of 1839.06 feet to a mag nail set at the southwest corner of a 38.77 acre tract conveyed to Jane E Berlin (3/4) and Jane E Berlin, Trustee (1/4) by Official Record 242 page 1201, the Southeast corner of said 163.708 acre tract and being the **True Point of Beginning**;

Thence, with the centerline of Gregg Road, **North 82° 47' 07" West** a distance of **665.81 feet** to a mag nail set;

Thence, with a new line across said 163.708 acre tract, **North 07° 47′ 25″ East**, passing an iron pin and cap set at 20.37 feet, a total distance of **2852.99 feet** to an iron pin and cap set in the South line of a 74.2560 acre tract conveyed to Gary L and David T Scheiderer by Official Record 227 page 954;

Thence, with the South line of said 74.2560 acre tract, **South 81° 48' 27" East** a distance of **866.28 feet** to a 1 inch solid iron bar found in the West line of a 309.27 acre tract conveyed to James Lee and Elizabeth Anne Adelsberger, Joint Lives by Official Record 352 page 940;

Thence, with the West line of said 309.27 acre tract, **South 08° 14′ 57″ West** a distance of **1904.36 feet** to an iron pin and cap set in the North line of said Berlin's 38.77 acre tract and in the line between VMS 7628 and 12128;

Thence, around said 38.77 acre tract and said VMS line with the following two courses:

- 1) **South 84° 21' 45" West** a distance of **195.13 feet** to a point;
- 2) leaving said VMS line, **South 07° 29′ 46″ West**, passing iron pin and caps set at 20.00 feet and 873.62 feet, a total distance of **890.63 feet** returning to the **True Point of Beginning**, containing **52.0000 Acres** more or less.

Commencing at a monument box found at the centerline intersection of Gregg Road (County Road 43, 50 feet right-of-way) and State Route 142 (60 feet right-of-way);

Thence, with the centerline of Gregg Road the following 4 courses:

- 1) South 35° 50′ 08″ East, passing a railroad spike found in the north line of a 39.899 acre tract (Railroad) conveyed Pennsylvania Lines, LLC by Deed Book 237 page 255 at 707.17 feet, a total distance of 809.68 feet to a railroad spike found in the south line of said railroad
- 2) South 36° 01′ 10″ East a distance of 1302.42 feet to a ¾″ tee bar and cap found
- 3) South 04° 50′ 25″ West a distance of 1530.74 feet to a ¾″ tee bar and cap found
- 4) South 82° 47′ 41″ East a distance of 2194.27 feet to a Mag nail set at the southeast corner of a 129.053 acre tract conveyed to Phillipi Farms by Official Record 261 page 1629 and the southwest corner of said 163.708 acre tract, said mag nail is also **The True Point of Beginning**;

Thence, with the east line of said 129.053 acre tract the following four courses:

- 1) North 06° 37′ 36″ East, passing an iron pin and cap set at 22.42 feet, a total distance of 2824.81 feet to an iron pin and cap set at the base of a 6″ wood fence post;
- 2) North 07° 10′ 01″ West a distance of 147.14 feet to an iron pin and cap set at the base of a 6″ wood fence post;
- 3) North 31° 22′ 31″ West a distance of 167.49 feet to a 1 inch solid iron bar found;
- 4) **North 00° 38′ 53″ West**, passing an iron pin and cap set at 1007.09 feet, a total distance of **1034.99 feet** to the southeast line of said Railroad;
