

SURVEY PLAT

PATRIDGE SURVEYING LLC

LEGAL DESCRIPTION OF 4.000 ACRE TRACT

Situated in the State of Ohio, County of Madison, Township of Deercreek, located in Virginia Military Survey Number 8767 and being part of a 447.93 acre tract (225.75 acre tract (Tract II)) (Par. No. 06-00016.000) conveyed to David A. and LaDonna L. Thomas in Deed Book 286, Page 312, Madison County Recorder's Office), and being more particularly described as follows;

Beginning, for reference, at an iron pin found at the intersection of the centerlines of Lafayette-Plain City Road (C.R. 5) and State Route 29, marking the northeast corner of 39.282 (Tract H) conveyed to Paul and Emmett Schrock in Official Record 98, Page 1739;

thence South 19° 55' 20" West 1444.63 feet, in the centerline of Lafayette-Plain City Road, to a railroad spike found at the northeast corner of said 447.93 acre tract, (Tract II), now being the northeast corner of a 2.00 acre tract conveyed to Kevin W. & Julie R. Crossley in Official Record 123, Page 1891, and the southeast corner of said 39.282 acre tract,

thence North 65° 02' 19" West 311.18 feet, along the north line of said 2.00 acre tract and south line of said 39.282 acre tract (passing an iron pin found at 30.11 feet), to an iron pin found marking the northwest corner of said 2.000 acre tract and marking the <u>PRINCIPAL PLACE OF BEGINNING</u>, of the herein described tract;

thence South 19° 58' 48" West 281.02 feet, along the west line of said 2.000 acre tract, to an iron pin found marking the southwest corner of said 2.000 acre tract;

thence North 65° 02' 19" West 622.38 feet, across said 447.93 acre tract, to an iron pin set;

thence North 19° 58' 48" East 281.02 feet, across said 447.93 acre tract, to an iron pin set in the north line of said 447.93 tract (Tract II) and in the south line of said 39.282 acre tract;

thence South 65° 02' 19" East 622.38 feet, along the north line of said 447.93 tract (Tract II) and south line of said 39.282 acre tract, to the true place of beginning, containing an area of <u>4.000</u> <u>acres.</u> Subject to all easements of record, if any.

Basis of bearings from GPS observation (Ohio SPC South Zone), based on the centerline of Lafayette-Plain City Road being South 19° 58' 48" West. A survey was done by Bradley J. Patridge P.S. 7068, in September, 2021.

All iron pins set are 5/8" rebar, capped "Patridge Surveying". All iron pipes found are 5/8".
