Description of a 0.099 Acre Property

This description is for a 0.099 acre (4,298.0 square feet) (includes a 0.081 acre and a 0.018 acre tract) property in the name of Leanna M. Bowers (Official Records 301, Page 817, Madison County Recorder, Auditor's I.D. 31-02965.000 and 31-02966.000) located at 50 Laurel Street (50 foot Right-of-way), London, in Virginia Military Survey 6324, Madison County, Ohio, and is further described as follows:

Commencing at a 1/2 inch diameter Iron Pipe found at the northernmost corner of Lot 2 of the *Lilly Addition to London* (Plat Book 1, Page 105), at the corner of the southeast R/W of East First Street (60 foot R/W) and the southwest R/W of said Laurel Street;

Thence N12°32'06"W, 30.06 feet, to the intersection of the center of said West First St. and said Laurel St.;

Thence N30°15'54"W, 158.16 feet, along the centerline of said Laurel St. to a point;

Thence N59°44'06"E, 25.00 feet, to an Iron Pin set at intersection of the northeast R/W of said Laurel St. and the southeast R/W of a 16.5 foot alley, at the TRUE POINT OF BEGINNING;

Thence N68°08'57"E, 85.19 feet, along the southeast R/W of the said alley, passing the westernmost corner of the said 0.018 acre tract at 67.13 feet, to an Iron Pin set at the westernmost corner of a 0.216 acre property in the name of Gregory A. and Mary M. Booth (O.R. 103, Page 2427);

Thence S22°12'22"E, 53.25 feet, along the southwest line of the said Booth property, to an Iron Pin fd. with an ID Cap *ELLIOTT PS7759* at the northeast corner of a 0.01 acre property in the name of Donald & Leigh Porr (1/2 interest) and Michael & Patricia Carpenter (1/2 interest) (O.R. 333, Page 130);

Thence S68°51'29"W, 77.79 feet, along the northwest line of the said Porr-Carpenter property, passing the southwest corner of the said 0.018 acre tract and the northeast corner of a 0.113 acre property in the name of said Porr-Carpenter, at 10.73 feet, to an Iron Pin fd. at the northwest corner of the said Porr-Carpenter property and in the northeast R/W of said Laurel St.;

Thence N30°15'54"W, 52.86 feet, along the northeast R/W of said Laurel St. to the TRUE POINT OF BEGINNING.

Said property contains 0.099 acres in the City of London and in V.M.S. 6324. The Basis of Bearing is N30°15'54"W along the centerline of said Laurel Street as measured by G.P.S. surveying methods adjusted to State Plane Coordinates 3402 OHIO SOUTH (NAD83(2011)). This description is based on a survey performed in January of 2021 by Casey Elliott, PS7759, State of Ohio. Pins set are 5/8" diameter iron pins with yellow identification caps engraved *ELLIOTT PS-7759*. This survey and description meet the MINIMUM STANDARDS FOR BOUNDARY SURVEYS IN OHIO, as described in Chapter 4733-37 of the Ohio Administrative Code.
