SURVEY FOR GRAFRIAR FARMS, LLC 19.012 Acres May 14, 2021

The following described 19.012 acre tract is situated in the State of Ohio, County of Madison, Township of Somerford, V.M.S. 5198 and V.M.S. 4125, being part of Grafriar Farms, LLC's 93.539 acre tract described in O.R. 173, Pg. 2557 (Parcel No. 24-00446.000), and part of Grafriar Farms, LLC's 26.637 acre tract described in O.R. 228, Pg. 356 (Parcel No. 24-01499.006), and said 19.012 acre tract being more particularly described as follows:

Beginning for reference at a 1 inch iron pipe found at an angle point in the centerline of Arbuckle Road (40 feet wide), said pipe being in the east line of V.M.S. 12916, in the west line of V.M.S. 4125, and at an angle point in the south line of said 26.637 acre tract;

Thence North 83°05'22" East 590.72 feet, following the centerline of Arbuckle Road and entering V.M.S. 4125, following a south line of said 26.637 acre tract, to a magnetic nail set and marking the *place of beginning*;

Thence *North 14°21'00" West 88.43 feet*, departing from the centerline of Arbuckle Road and entering said 26.637 acre tract, passing at 20.17 feet and iron pin set, to an iron pin set;

Thence continuing through said 26.637 acre tract along the following courses:

Thence *North 37°13'18" West 398.41 feet*, following a northeast line of said 7.1486 acre tract and a southwest line of said 93.539 acre tract, to an iron pin set;

Thence *South 55°04'25" West 257.08 feet*, following a northwest line of said 7.1486 acre tract and a southeast line of said 93.539 acre tract, to a 5/8 inch iron pin found with cap marked "Barker S-5539:

Thence *South 81°02'10" West 91.10 feet*, following a north line of said 7.1486 acre tract and a south line of said 93.539 acre tract, to a 5/8 inch iron pin found with cap marked "Barker S-5539";

Thence *North 38°27'35" West 184.85 feet*, following a northeast line of said 7.1486 acre tract and a southwest line of said 93.539 acre tract, to a 5/8 inch iron pin found with cap marked "Barker S-5539";

Thence *South 50°55'35" West 288.42 feet*, following a northwest line of said 7.1486 acre tract and a southeast line of said 93.539 acre tract, passing at 268.42 feet an iron pin set, to a magnetic nail found on the centerline of Arbuckle Road;

Thence *North 36°58'24" West 411.70 feet*, following the centerline of Arbuckle Road, a southwest line of said 93.539 acre tract, the southwest line of V.M.S. 5198, and the northeast line of V.M.S. 4125, to a ¾ inch iron pipe found at a northeast corner of said 26.637 acre tract;

Thence North 83°05'22" East 843.48 feet, following the centerline of Arbuckle Road and entering V.M.S. 4125, passing at 590.72 feet a magnetic nail set, to a ¾ inch iron pipe found in the southwest line of Grafriar Farms, LLC's 93.539 acre tract described in O.R. 173, Pg. 2557 (Parcel No. 24-00446.000), in the southwest line of V.M.S. 5198, and in the northeast line of V.M.S. 4125;

Thence South 36°58'24" East 411.70 feet, following the centerline of Arbuckle Road, the southwest line of said 93.539 acre tract and V.M.S. 5198, and the northeast line of V.M.S. 4125, to a magnetic nail found at the westerly corner of said 7.1486 acre tract, said nail marking the *place of beginning*;

Thence *North 50°55'35" East 288.42 feet*, departing from the centerline of said Road and entering said V.M.S. 5198, following a northwest line of said 7.1486 acre tract and a southeast line of said 93.539 acre tract, passing at 20.00 feet an iron pin set, to a 5/8 inch iron pin found with cap marked "Barker S-5539";
