

## SURVEY FOR TOM HOSTETLER 0.665 Acre June 25, 2021

The following described 0.665 acre tract is situated in the State of Ohio, County of Madison, Township of Darby, V.M.S. 8539, and being part of Thomas D. and Delores A. Hostetler's 108.483 acre tract described in O.R. 231, Pg. 551 (Parcel No. 02-00113.000), and said 0.665 acre tract being more particularly described as follows:

Beginning for reference at a magnetic nail found at the intersection of the centerline of Converse-Chapel Road (C.R. 41, 50' R/W) with the centerline of Converse-Huff Road (C.R. 30), said magnetic nail marking the southeast corner of said 108.483 acre tract;

Thence North 09°09'28" East 1138.38 feet, following the centerline of Converse-Huff Road, to a railroad spike found at a northeast corner of said 108.483 acre tract and at the southeast corner of Jesse Lynn Hostetler's 1.000 acre tract described in O.R. 377, Pg. 28;

Thence North 84°50'28" West 183.65 feet, departing from the centerline of Converse-Huff Road, following the south line of said 1.000 acre tract and a north line of said 108.483 acre tract, passing at 25.92 feet a "T" post found, also passing at 179.85 feet a point being 0.12 feet south of a "T" post found, to an iron pin set and marking the *place of beginning*;

Thence North 84°50'28" West 122.22 feet, entering said 108.483 feet, to an iron pin set;

Thence *North 9°09'28" East 237.66 feet*, continuing through said 108.483 acre tract, to an iron pin set in the south line of Ernest A. and Bertha M. Beachy's 92.34 acre tract described in O.R. 362, Pg. 1794;

Thence *South 84°50'28" East 122.22 feet*, following the south line of said 92.34 acre tract and a north line of said 108.483 acre tract, to an iron pin set at the northwest corner of said 1.000 acre tract;

Thence South 9°09'28" West 237.66 feet, following the west line of said 1.000 acre tract and an east line of said 108.483 acre tract, to the place of beginning, containing 0.665 acre, more or less, and being subject to all valid easements and restrictions of record.

The above described 0.665 acre tract has no road frontage and is to be attached to Jesse Lynn Hostetler's 1.000 acre tract.

The above description was prepared from an actual field survey made under the supervision of Paul R. Clapsaddle, Registered Surveyor 6140, during the month of June 21. Iron pins set are 5/8" by 30" reinforcing rods with caps marked "CLAPSADDLE RS 6140". Bearings indicated herein are based on State Plane Coordinate, South Zone, NAD 83, and GPS field observations.
