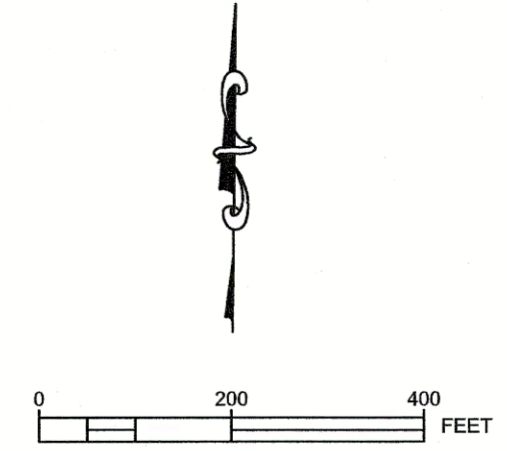

Situate in Virginia Military Survey Lot No. 6286 and 9717, in the Township of Fairfield, County of Madison, State of Ohio, and being all of a 5.169 acre tract, split from a 100.00 acre tract of land as conveyed to Donald Wayne Francis by deed recorded in Official Record Volume 108, page 1671 and Gary Shipley and Wayne Francis by deed recorded in Deed Book 283, page 759, and all of a 0.783 acre tract, split from a 129.142 acre tract of land as conveyed to Donald Wayne Francis by deed recorded in Official Record Volume 108, page 1671 and Gary Shipley and Wayne Francis by deed recorded in Deed Book 283, page 761 (all references to deeds, microfiche, plats, surveys, etc. refer to the records of the Madison County Recorder's Office, unless noted otherwise) and being more particularly bounded and described as follows:

BEGINNING at a railroad spike found at an angle point on the west line of said 100.00 acre tract of land and at the southeast corner of a 74.275 acre tract of land as conveyed to Jan S. Maki, Trustee of the Jan S. Maki Living Trust dated April 25, 2002 by deed recorded in Official Record 294, page 1345 and the northeast corner of a 119.625 acre tract of land as conveyed to James R. Hume by deed recorded in Official Record 294, page 1349 and on the centerline of McGuire Road (County Road 64 – 40' public right of way);

thence across said 100.00 acre tract and along the centerline of said McGuire Road, South seventy-one degrees five minutes twenty-one seconds East (S71°05'21"E), for forty and 5/100 feet (40.05') to a MAG nail set;

thence continuing across said 100.00 acre tract for the following four (4) courses:

1. South twenty-one degrees forty-seven minutes fifty-seven seconds West (S21°47'57"W), for seven hundred seventy and 1/100 feet (770.01') to an iron pin set;
2. South forty-five degrees fifty-seven minutes fifty-nine seconds West (S45°57'59"W), for one thousand three hundred eighteen and 32/100 feet (1,318.32') to an iron pin set;
3. South eighty-seven degrees fifty-six minutes fifty seconds East (S87°56'50"E), for two hundred sixty-seven and 96/100 feet (267.96') to an iron pin set;
4. South two degrees three minutes ten seconds West (S02°03'10"W), for four hundred and 00/100 feet (400.00') to an iron pin set;

thence continuing across said 100.00 acre tract and across said 129.142 acre tract, North eighty-seven degrees fifty-six minutes fifty seconds West (N87°56'50"W), for four hundred sixty-four and 00/100 feet (464.00') to an iron pin set;

thence continuing across said 129.142 acre tract, North two degrees three minutes ten seconds East (N02°03'10"E), for two hundred fifty-four and 5/100 feet (254.05') to an iron pin set on the west line of said 129.142 acre tract and the east line of said 119.625 acre tract;

thence along said lines and along the west line of said 100.00 acre tract, North forty-five degrees fifty-seven minutes fifty-nine seconds East (N45°57'59"E), for one thousand five hundred fifty and 87/100 feet (1,550.87') to an iron pin set;

thence continuing along said lines, North twenty-one degrees forty-seven minutes fifty-seven seconds East (N21°47'57"E), for seven hundred fifty-nine and 42/100 feet (759.42') to the POINT OF BEGINNING, containing 5.952 acres, more or less, subject however to all covenants, conditions, restrictions, reservations, and easements contained in any instrument of record pertaining to the above described tract of land.

Iron pins set are 5/8" rebar, 30" in length, with a plastic plug placed on top inscribed with the name "WOOLPERT INC", unless otherwise noted. All monuments found are in good condition unless otherwise noted.

Bearings are based upon the Ohio State Plane Coordinate System, South Zone, NAD83 (2011). Said bearings originated from said coordinate system by GPS observations and observations of selected stations in the National Geodetic Survey Continuously Operating Reference Station (NGS CORS) Network.

This description was prepared under the direction of Gary S. Swierz, Ohio Registered Surveyor No. 7776, of Woolpert Inc., based upon a field survey performed during July, 2020.
