8.3711 Acre Tract

Surveyed for Hedgerow Farm LLC

The following described 8.3711 acre tract is situated in the State of Ohio, Madison County, Canaan Township, VMS 1618, being part of a 62.0707 acre tract (Parcel 01-00383.000, 67.16 original acres) conveyed to Hedgerow Farm LLC by Official Record 349 page 266, and being more particularly described as follows:

Beginning at a mag nail set in the centerline of Hayden Run Road (County Road 38, 45 feet right-of-way) at the East corner of a 0.5000 acre tract conveyed to George R Roby by Official Record 345 page 815 and a corner to said 62.0707 acre tract, and being in the line between VMS 1618 and VMS 7693, said mag nail bears North 57° 14′ 27″ East a distance of 2193.60 feet from an iron pin found at the centerline intersection of Hayden Run Road with Carters Mill Road (County Road 39, 45 feet right-of-way);

Thence, around said 0.5000 acre tract with the following two courses:

- 1) **North 32° 47' 50" West**, passing an iron pin and cap previously set at 21.39 feet, a total distance of **219.95 feet** to an iron pin and cap previously set;
- 2) **South 57° 14′ 27" West**, passing a 3/4 inch diameter iron pipe found at the North corner of a 1.1195 acre tract conveyed to George R Roby by Official Record 224 page 1590 at 99.02 feet, continuing with the Northwest line of said 1.1195 acre tract, passing a 3/4 inch diameter iron pipe found at the North corner of a 1.4361 acre tract at 320.73 feet, continuing with the Northwest line of said 1.4361 acre tract, a total distance of **604.52 feet** to an iron pin and cap previously set at the West corner of said 1.4361 acre tract;

Thence, across said 62.0707 acre tract with the following two new courses:

- 1) North 32° 26′ 48″ West a distance of 221.39 feet to an iron pin and cap set;
- North 57° 22′ 32″ East, passing an iron pin and cap set at 1076.55 feet, a total distance of 1126.55 feet to the Southwest line of a 102.750 acre tract conveyed to Makapa LLC by Official Record 350 page 1927;

Thence, with the Southwest line of said 102.750 acre tract, **South 33° 29' 14" East**, passing an iron pin and cap set at 418.53 feet, a total distance of **439.88 feet** to a railroad spike found in the centerline of Hayden Run Road and in the line between VMS 1618 and VMS 7693;

Thence, with the centerline of Hayden Run Road and with said VMS line, **South 57° 22' 00" West** a distance of **528.68 feet** returning to the Point of Beginning, containing 8.3711 Acres more or less.

Bearings are based on a GPS observation on August 2, 2018, WGS 1984 Geodetic North.

Subject to and with the benefit of all legal highways, restrictions, easements, limitations, and reservations, of record, if any and to zoning restrictions which have been imposed thereon, if any.

All iron pins set are 5/8-inch diameter rebar with yellow plastic cap stamped "Cottrill Surveying"
