### 2.0000 Acre Tract

 Surveyed for BidwellThe following described 2.0000 acre tract is situated in the State of Ohio, Madison County, Canaan Township, VMS 2681, being part of a 29.2512 acre tract conveyed to Dale Bidwell by Official Record 224 page 1292, and being more particularly described as follows:
Commencing at an iron pin found in the centerline of Plain City-Georgesville Road (County Road 7, 50 feet right-of-way) at the North corner of a 1.00 acre tract conveyed to Thomas M and Billie K Bidwell, Trustees by Official Record 135 page 483 and the Southeast corner of a 57.46 acre tract conveyed to Martha E and Paul E Yutzy, Trustees by Official Record 181 page 1790 , said iron pin bears South $00^{\circ} 47^{\prime} 14^{\prime \prime}$ West a distance of 233.83 feet from a mag nail found at the intersection of the centerline of Plain City-Georgesville Road with the South line of Darby Lake Drive;

Thence, with the Southeast line of said 57.46 acre tract, South $56^{\circ} 57^{\prime} 31^{\prime \prime}$ West, passing a corner to a 2.0095 acre tract conveyed to Nathan Thomas Bidwell by Official Record 400 page 1789 at 391.04 feet, a total distance of 568.04 feet to an iron pipe and aluminum cap stamped "NCB 5969" found at the West corner of said 2.0095 acre tract, corner to said 29.2512 acre tract and being the True Point of Beginning;
Thence, with the Southwest line of said 2.0095 acre tract, South $\mathbf{3 3 ^ { \circ }} \mathbf{0 2} \mathbf{0 2}^{\prime} \mathbf{2 0}$ East a distance of $\mathbf{2 7 5 . 6 1}$ feet to an iron pipe and aluminum cap stamped "NCB 5969" found at the South corner of said 2.0095 acre tract;

Thence, across said 29.2512 acre tract with the following two new courses:

1) South $56^{\circ} 58^{\prime} \mathbf{3 8 \prime \prime}$ West a distance of 316.15 feet to an iron pin and cap set;
2) North $33^{\circ} \mathbf{0 2} \mathbf{~ 2 0 \prime \prime}$ West a distance of $\mathbf{2 7 5 . 5 1}$ feet to an iron pin and cap set in the Southeast line of said Yutzy's 57.46 acre tract;

Thence, with the Southeast line of said 57.46 acre tract, North $56^{\circ} 57^{\prime} 31^{\prime \prime}$ East a distance of $\mathbf{3 1 6 . 1 5}$ feet returning to the True Point of Beginning, containing 2.0000 Acres more or less.
Bearings are based on a GPS observation on May 12018, WGS 1984 Geodetic North.

Subject to and with the benefit of all legal highways, restrictions, easements, limitations, and reservations, of record, if any and to zoning restrictions which have been imposed thereon, if any.
All iron pins set are $5 / 8$-inch diameter rebar with yellow plastic cap stamped "Cottrill Surveying"
