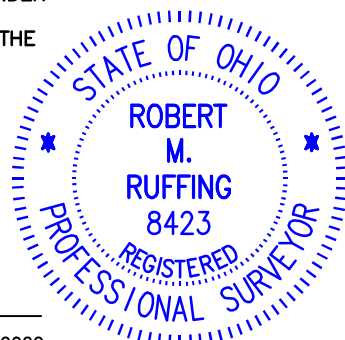

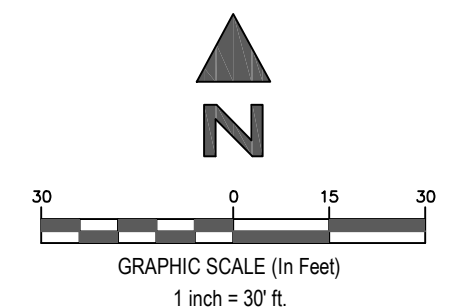
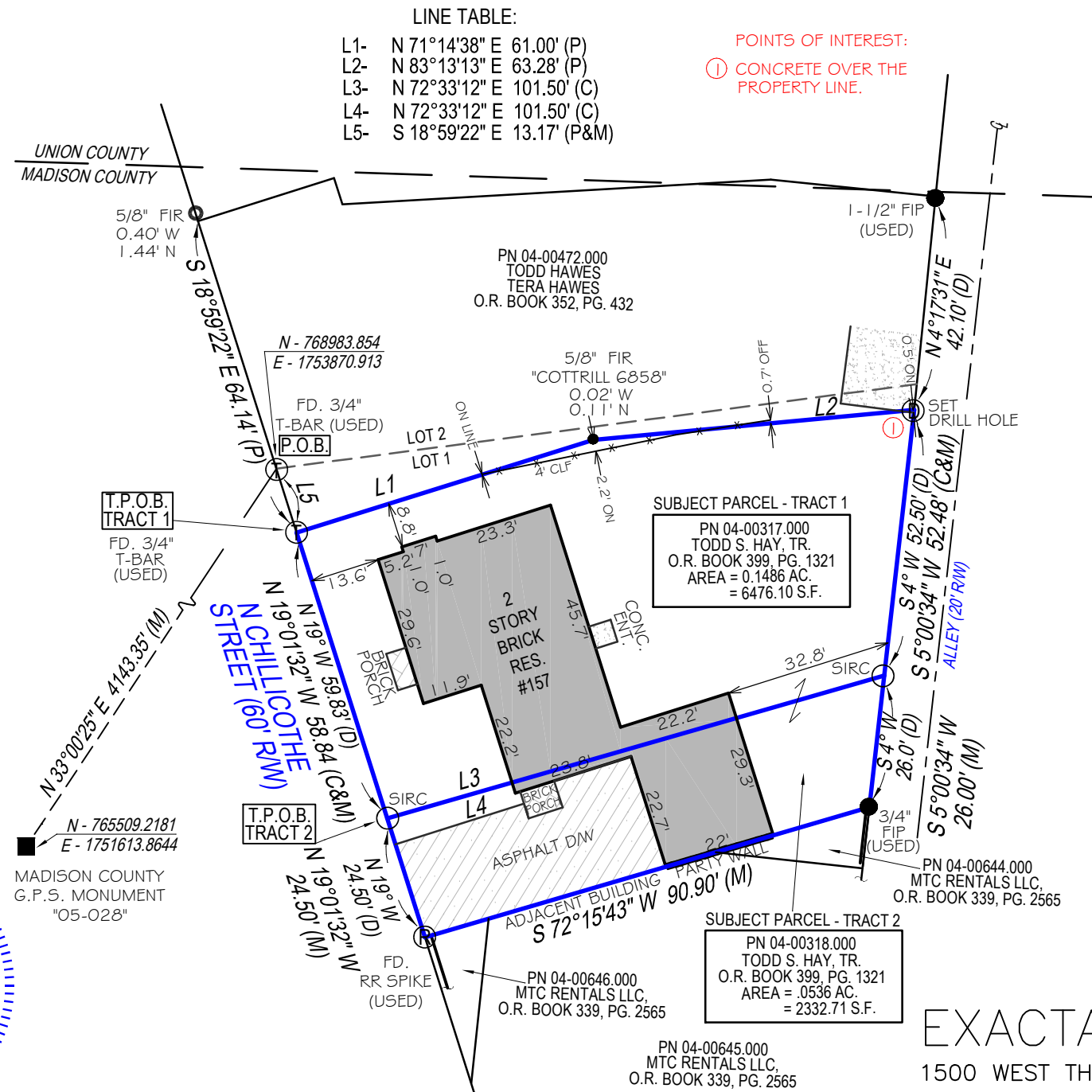

LEGAL DESCRIPTION

for 157 North Chillicothe Street (U.S. 42)

Plain City, Ohio

Tract 1 - Parcel Number 04-00317.000

Situated in the City of Plain City, County of Madison, and State of Ohio, and being part of Lot 1 of Pleasant Valley – Edmund Barlow’s Addition (Plat Book 1, Pages 41-42), records are from the Madison County Recorder’s Office, and being conveyed to Todd S. Hay, Trustee (PN 04-00317.000), bounded and described as follows:

Beginning at a found and used 3/4” T-bar (cap missing) along the east side of North Chillicothe Street (60’) at the common corner of Lots 1 and 2 of said Edmund Barlow’s Addition, also being along the west line of lands conveyed to Todd and Tera Hawes (PN 04-00472.000);

Thence along the east line of said street, S 18°59’22” E, 13.17 feet to a found and used 3/4” T-bar (cap missing) at the southwest corner of said Hawes lands, and the True Point of Beginning at the northwest corner of the parcel herein described:

Thence leaving said street and along the south line of said Hawes lands, N 71°14’38” E, 61.00 feet to an angle point on the north line, as monumented by a 5/8” capped iron pin (“COTTRILL 6858”), found 0.02 feet west and 0.11 feet north of the angle point;

Thence continuing along the south line of said Hawes lands, N 83°13’13” E, 63.28 feet to set drill hole in concrete at the northeast corner, said point being the southeast corner of said Hawes lands and along the west line of a 20’ alley;

Thence along the west line of said alley, S 5°00’34” W, 52.48 feet to a set 5/8” x 30” capped iron pin (“LANDMARK SURVEYING”) the southeast corner said point also being the northeast corner of Tract 2 conveyed to Todd S. Hay, Trustee (PN 04-00318.000);

Thence leaving said west line and along the common line of Tracts 1 and 2, S 72°33’12” W, 101.50 feet to a set 5/8” x 30” capped iron pin (“LANDMARK SURVEYING”) at the southwest corner at the east line of said Chillicothe Street;

Thence along said east line, N 19°01’32” W, 58.84 feet to the True Point of Beginning, containing 6476.10 square feet, or 0.1486 acres, and subject to all legal highways, easements, reservations or restrictions of record, if any.

Situated in the City of Plain City, County of Madison, and State of Ohio, and being part of Lot 1 of Pleasant Valley – Edmund Barlow’s Addition (Plat Book 1, Page 41-42), records are from the Madison County Recorder’s Office, and being conveyed to Todd S. Hay, Trustee (PN 04-00318.000), bounded and described as follows:

Beginning at a found and used 3/4” T-bar (cap missing) along the east side of North Chillicothe Street (60’) at the common corner of Lots 1 and 2 of said Edmund Barlow’s Addition, also being along the west line of lands conveyed to Todd and Tera Hawes (Inst #201900002118);

Thence along the east line of said street, S 18°59’22” E, 13.17 feet to a found and used 3/4” T-bar (cap missing) at the southwest corner of said Hawes lands, also being the northwest corner of Tract 1, conveyed to Todd S. Hay, Trustee (Inst #202200001822);

Thence continuing along said east line, S 19°01’32” E, 58.84 feet to a set 5/8” x 30” capped iron pin (“LANDMARK SURVEYING”) at the southwest corner of Tract 1, and the True Point of Beginning at the northwest corner of the parcel herein described:

Thence leaving said street and along the south line of said Tract 1, N 72°33’12” E, 101.50 feet to set 5/8” x 30” capped iron pin (“LANDMARK SURVEYING”) at the northeast corner, also being the southeast corner of said Tract 1 and along the west line of a 20’ alley;

Thence along the west line of said alley, S 5°00’34” W, 26.00 feet to a found and used 3/4” iron pipe the southeast corner, said point also being the northeast corner of lands conveyed to MTC Rentals, LLC (PN 04-00645.000);
