

## Cottrill Surveying, Inc

### 2.5000 Acre Tract Surveyed for Curry

The following described 2.5000 acre tract is situated in the State of Ohio, Madison County, Jefferson Township, VMS 10689, being part of a 216.278 acre tract (Parcel 08-00613.000) conveyed to Robert F Schafer, Trustee of the Sidney K Schafer Revocable Living Trust by Official Record 315 page 2581, and being more particularly described as follows:

Commencing at an iron pin found at the centerline intersection of Wilson Road (County Road 103, 50 feet right-of-way) and Gregg Road (County Road 43);

Thence, with the centerline of Wilson Road with the following three courses:

1) North $02^{\circ} 13^{\prime} 12^{\prime \prime}$ East a distance of 19.34 feet to a railroad spike found;
2) North $60^{\circ} 55$ minute $05^{\prime \prime}$ East a distance of 921.12 feet to a railroad spike found;
3) North $39^{\circ} 49^{\prime} 33^{\prime \prime}$ East a distance of 123.20 feet to a mag nail set at the North corner of a 20.8362 acre tract conveyed to J'nel A Zucco by Official Record 254 page 980 and the West corner of said 216.278 acre tract and being the True Point of Beginning;
Thence, with the centerline of Wilson Road with the following two courses:
4) North $45^{\circ} \mathbf{5 8} \mathbf{8 N}^{\prime} \mathbf{2 3 \prime}$ East a distance of $\mathbf{1 5 3 . 6 5}$ feet to a mag nail found in the Northwest line of VMS 10698 and being a corner to VMS 10505 and VMS 10585;
5) with the line between VMS 10698 and 10505 , North $6 \mathbf{0 0}^{\circ} \mathbf{1 3} \mathbf{1 3}^{\prime} \mathbf{2 3 \prime}$ East a distance of $\mathbf{7 1 . 3 5}$ feet to a mag nail set;

Thence, across said 216.278 acre tract with the following two new courses:

1) South $\mathbf{2 9}{ }^{\circ} \mathbf{1 8} \mathbf{\prime \prime} \mathbf{3 4 \prime}$ East, passing an iron pin and cap set at 19.52 feet, a total distance of 508.77 feet to an iron pin and cap set and buried 1 foot deep;
2) South $60^{\circ} \mathbf{4 1} \mathbf{2 6 \prime \prime}$ West a distance of $\mathbf{2 1 9 . 9 6}$ feet to an iron pin and cap set in the Northeast line of said Zucco's 20.8362 acre tract;
Thence, with the Northeast line of said 20.8362 acre tract, North $\mathbf{2 9}^{\circ} \mathbf{1 8} \mathbf{~ 3 4 " ~ W e s t , ~ p a s s i n g ~ a n ~}$ iron pin and cap set at 428.31 feet, passing a railroad spike found at 461.54 feet, a total distance of 469.15 feet returning to the True Point of Beginning, containing 2.5000 Acres more or less.
Bearings are based on a GPS observation on August 6, 2018, WGS 1984 Geodetic North.
This deed is subject to and with the benefit of all legal highways, restrictions, easements, limitations, and reservations, of record, if any and to zoning restrictions which have been imposed thereon, if any.
All iron pins set are $5 / 8$-inch diameter rebar with yellow plastic cap stamped "Cottrill Surveying"
