## **0.3407 Acre Tract** Surveyed for Gossard

The following described 0.3407 acre tract is situated in the State of Ohio, Madison County, Union Township, VMS 8864, being part of a 22.255 acre tract (Parcel 30-00059.000, 25.02 original acres) conveyed to Lamar Gossard, TOD William R Gossard by Official Record 330 page 1882, and being more particularly described as follows:

Commencing at a mag nail found in the centerline of State Route 56 at the North corner of a 1.00 acre tract conveyed to Joel P and Brandy A Green, Joint Lives by Official Record 328 page 800 and the East corner of a 0.687 acre tract conveyed to Lamar Gossard, TOD Marcella Bogenrife by Official Record 330 page 1880, said mag nail bears North 34° 43' 14" West a distance of 371.11 feet from the intersection of State Route 56 with Mary Lou Drive (Private Road) and being the West corner of a 2.00 acre tract conveyed to Austin Steele by Official Record 378 page 1 804;

Thence, with the line between said 1.00 acre and 0.687 acre tracts, South 54° 26' 28" West a distance of 188.57 feet to a 3/4 inch T-bar and cap found at the South corner of said 0.687 acre tract and corner to said 22.255 acre tract and being the **True Point of Beginning**;

Thence, continuing with the Northwest line of said 1.00 acre tract, **South 54° 26' 28" West** a distance of **118.83 feet** to an iron pin and cap set at the West corner of said 1.00 acre tract;

Thence, across said 22.255 acre tract with the following two new courses:

- 1) North 25° 57' 46" West a distance of 112.30 feet to an iron pin and cap set;
- 2) North 28° 00' 03" East a distance of 114.96 feet to a 3/4 inch T-bar and cap found at the South corner of a 0.251 acre tract conveyed to James D and Judy C Carter, Joint Lives by Official Record 133 page 1013 and the West corner of said Gossard's 0.687 acre tract;

Thence, with the Southwest line of said 0.687 acre tract, **South 34° 33' 37" East** a distance of **161.94 feet** returning to the **True Point of Beginning**, containing **0.3407 Acres** more or less.

Commencing at a mag nail found in the centerline of State Route 56 at the North corner of a 1.00 acre tract conveyed to Joel P and Brandy A Green, Joint Lives by Official Record 328 page 800 and the East corner of a 0.687 acre tract conveyed to Lamar Gossard, TOD Marcella Bogenrife by Official Record 330 page 1880, said mag nail bears North 34° 43' 14" West a distance of 371.11 feet from the intersection of State Route 56 with Mary Lou Drive (Private Road) and being the West corner of a 2.00 acre tract conveyed to Austin Steele by Official Record 378 page 1 804;

Thence, with the line between said 1.00 acre and 0.687 acre tracts, South 54° 26′ 28″ West a distance of 307.40 feet to an iron pin and cap set at the West corner of said 1.00 acre tract and corner to said 22.255 acre tract and being the **True Point of Beginning**;

Thence, with the Southeast line of said 1.00 acre tract, **South 45° 59' 46" East** a distance of **174.65 feet** to a 3/4 inch diameter iron pipe found in the Northwest line of said Steele's 2.00 acre tract;

Thence, with the Northwest line of said 2.00 acre tract, **South 44° 17' 18" West**, passing the North corner of a 1.62 acre tract conveyed to William and Sandra Gossard, Joint Lives by Official Record 61 page 514 at 78.81 feet, passing a 3/4 inch diameter iron pipe found at the North corner of a 10.994 acre tract conveyed to Zachary I and Young Gossard by Official Record 384 page 365 at 563.17 feet, a total distance of **1719.31 feet** to a 3/4 inch diameter iron pipe found in the Northeast line of a 558.66 acre tract conveyed to the State of Ohio London Correctional Prison by Deed Book 88 page 554 and in the line between VMS 13567 and VMS 5429/8744;

Thence, with the Northeast line of said 558.66 acre tract and with said VMS line, **North 39° 01' 06" West** a distance of **537.05 feet** to an iron pin and cap previously set at the South corner of a 63.9355 acre tract conveyed to the State of Ohio FBO Ohio Department of Rehab and Corrections by Official Record 151 page 1081;

Thence, with the Southeast line of said 63.9355 acre tract, **North 44° 09' 04" East** a distance of **1848.59 feet** to the West corner of a 0.586 acre tract conveyed to Lamar L Gossard, TOD William R Gossard by Official Record 330 page 1882, from said corner a 1/2 inch diameter iron pin found bears North 44° 20' 51" West a distance of 0.29 feet;

Thence, with the Southwest line of said 0.586 acre tract, **South 34° 32' 54" East**, passing a 1/2 diameter iron pin found at the West corner of a 0.251 acre tract conveyed to James D and Judy C Carter, Joint Lives by Official Record 133 page 1013 at 129.61 feet, a total distance of **229.58 feet** to a 3/4 inch T-bar and cap found at the South corner of said 0.251 acre tract and the West corner of said Gossard's 0.687 acre tract;

Thence, across said 22.255 acre tract with the following two new courses:

- 1) South 28° 00' 03" West a distance of 114.96 feet to an iron pin and cap set;
- South 25° 57' 46" East a distance of 112.30 feet returning to the True Point of Beginning, containing 21.7316 Acres more or less.
