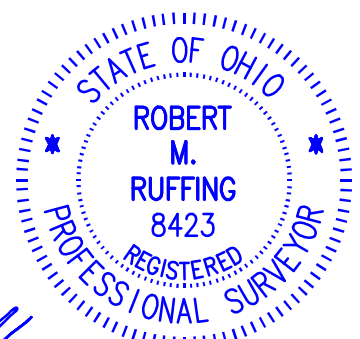

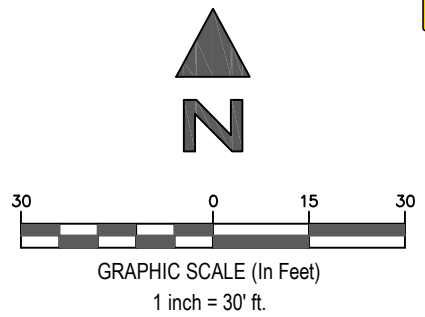
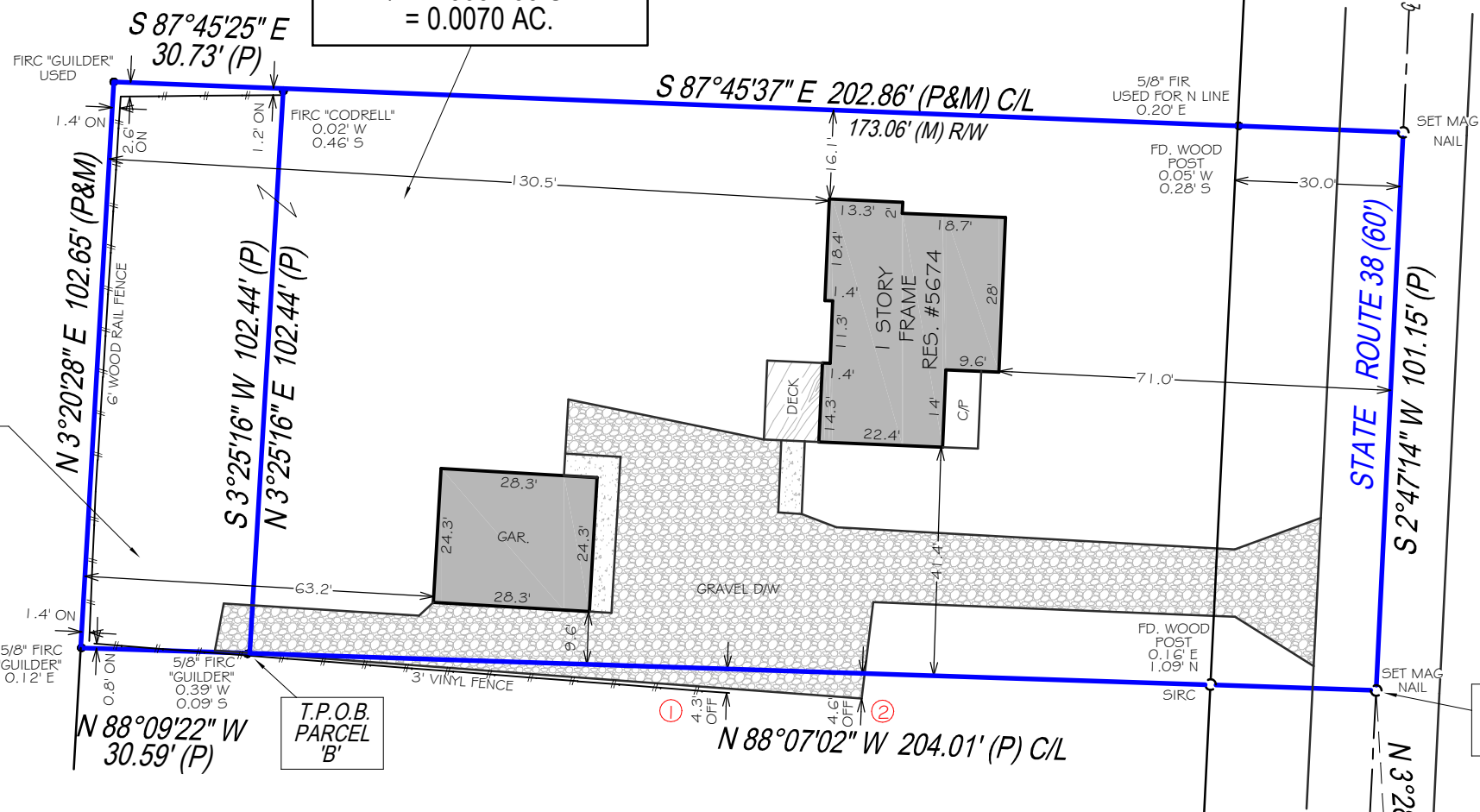

LEGAL DESCRIPTION

for Parcel Number 11-00028.000 (Parcel 'A')

at 5674 State Route 39

London, Ohio

Situated in the Township of Monroe, County of Madison and State of Ohio, in Virginia Military District 7473, conveyed to Ronald Stutzman and Edna Stutzman (O.R. Book 355, Page 157), bounded and described as follows:

Beginning at a found and used 3-inch brass disk ("Madison County Engineer Survey Monument 12-044") in a 1-foot diameter concrete monument 45 feet north of the intersection of State Route 38 and Arthur Bradley Road (C.R. 132);

Thence N 3°28'16" W, 4003.59 feet to a set Mag nail on the centerline of said State Route 38 at the northeast corner of a parcel conveyed to Jeremy Yoder (O.R. Book 391, Page 2368), also being the True Point of Beginning at the southeast corner of the parcel herein described in the following 4 courses:

Course 1: Thence leaving said centerline and along the north line of said Yoder lands, N 88°07'02" W, passing a set 5/8" x 30" capped iron pin ("LANDMARK SURVEY") along the west right of way of State Route 38 at 30.00 feet, a total distance of 204.01 feet to the southwest corner, as monumented by a 5/8" iron rod, capped ("GUILDER") found 0.39 feet west and 0.09 feet south of the corner; also being the southeast corner of Parcel 'B', conveyed to Ronald Stutzman and Edna Stutzman (O.R. Book 355, Page 157);

Course 2: Thence along the east line of Parcel 'B', N 3°25'16" E, 102.44 feet to the northwest corner, as monumented by a 5/8" iron rod, capped ("CODRELL") found 0.02 feet west and 0.46 feet south of the corner; also being along the south line of a parcel conveyed to Alan Clifton and Karri Clifton (O.R. Book 342, Page 1201);

Course 3: Thence along the south line of said Clifton lands, S 87°45'37" E, passing a 5/8" iron rod found on line and 0.20 feet east of the west right of way of State Route 38 at 173.06 feet, a total distance of 202.86 feet to a set Mag nail at the northeast corner on the centerline of State Route 38, also being the southeast corner of said Clifton lands;

Course 4: Thence along said centerline, S 2°47'14" W, 101.15 feet to the True Point of Beginning, containing a total of 20,704.97 square feet, or 0.4753 acres, including 3037.33 square feet, or 0.0700 acres within the right of way, and being subject to all legal highways, easements, reservations or restrictions of record, if any.

Beginning at a found and used 3-inch brass disk ("Madison County Engineer Survey Monument 12-044") in a 1-foot diameter concrete monument 45 feet north of the intersection of State Route 38 and Arthur Bradley Road (C.R. 132);

Thence N 3°28'16" W, 4003.59 feet to a set Mag nail on the centerline of said State Route 38 at the southeast corner of Parcel 'A' conveyed to Ronald Stutzman and Edna Stutzman (O.R. Book 355, Page 157), also the northeast corner of a parcel conveyed to Jeremy Yoder (O.R. Book 391, Page 2368);

Thence leaving said centerline and along the north line of said Yoder lands, N 88°07'02" W, passing a set 5/8" x 30" capped iron pin ("LANDMARK SURVEY") along the west right of way of State Route 38 at 30.00 feet, a total distance of 204.01 feet to the southwest corner of Parcel 'A', as monumented by a 5/8" iron rod, capped ("GUILDER") found 0.39 feet west and 0.09 feet south of the corner; also being the True Point of Beginning at the southeast corner of the parcel herein described in the following 4 courses:

Course 1: Thence continuing along the north line of said Yoder parcel, N 88°09'22" W, 30.59 feet to the southwest corner, as monumented by a 5/8" iron rod, capped ("GUILDER"), found 0.12 feet east and 0.00 feet north of the corner, also being the northwest corner of said Yoder lands and on an interior line of a parcel conveyed to Ronald Stutzman and Edna Stutzman (O.R. Book 355, Page 157);

Course 2: Thence along the east line of said Stutzman parcel, N 3°20'28" E, 102.65 feet to a found and used 5/8" iron rod, capped ("GUILDER") at the northwest corner, also being an interior corner of said Stutzman parcel;

Course 3: Thence along the south line of said Stutzman parcel, S 87°45'25" E, 30.73 feet to the northeast corner, as monumented by a 5/8" iron rod, capped ("CODRELL") found 0.02 feet west and 0.46 feet south of the corner, also being the northwest corner of said Parcel 'A';

Course 4: Thence along the west line of said Parcel 'A', S 3°25'16" W, 102.44 feet to the True Point of Beginning, containing a total of 3143.06 square feet, or 0.0723 acres, and being subject to all legal highways, easements, reservations or restrictions of record, if any.

The basis of bearings for this survey are from GPS observations using the Ohio State Plane Coordinate System, South Zone, NAD83 (CORS), holding found and used monumentation along the north line of Parcels 'A' and 'B' to establish an observed bearing of S 87°45'37" E along the north line of Parcel 'A'.

The intent of this legal description is to retrace and describe this parcel based on an actual field survey performed on June 5, 2023, by Exacta Land Surveyors, LLC.
