A tract of land being situated in the state of Ohio, County of Madison, and in the village of Jefferson. said tract of land being lots numbered sixty-four(64), sixty-five(65), sixty-six(66), and a 15 foot wide strip of land between lots sixty-five(65) and sixty-six(66) of Jones' First Addition to the Village of Jefferson, as the same is numbered and delineated upon the recorded plat thereof, of record in Plat Book 1, Page 1, recorder's office, Madison County, Ohio. said tract of land being further described as follows:

Beginning at a found 3/4-inch open-top pipe, being the Northwest corner of lot sixty-four(64), also being the intersection of the South right-of-way line of Highway Forty(40), also known as National Pike, and the East right-of-way line of South Heath Lane, and being the Northwest corner of the herein described tract;

Thence, run N 86°31'20" E, along the South right-of-way line of Highway Forty(40), a distance of 161.48 feet, to a found 3/4-inch open-top pipe at the Northeast corner of lot sixty-six(66), also being the Northeast corner of the herein described tract;

Thence, S 03°13'26" E, a distance of 150.01 feet, to a found 1/2-inch rebar with cap inscribed "COTTRILL 6058", being the Southeast corner of lot sixty-six(66), also being a point on the North right-of-way line of East Pearl Street, and being the Southeast corner of the herein described tract;

Thence, S 86°31'20" W, along the North right-of-way line of East Pearl Street, a distance of 161.48 feet, to a found 3/4-inch open-top pipe, being at the intersection of the North right-of-way line of East Pearl Street and the East right-of-way line of South Heath Lane, also being the Southwest corner of lot sixty-four(64), and being the Southwest corner of the herein described tract of land;

Thence, run N 03°13'26" W, along the East right-of-way line of South Heath Lane, also being the West line of lot sixty-four(64), a distance of 150.01 feet, to the point of beginning, containing therein 0.556 acres(24223 square feet) more or less, and intending to describe the same property conveyed to DLS Leasing, LLC, by virtue of deed filed March 6, 2002, and recorded in OR Volume 137, Page 1428, and by deed filed September 27, 2016, and recorded in OR Volume 321, Page 1780, of the Madison County Records.
