#### 15.0000 Acre Tract

The following described 15.0000 acre tract is situated in the State of Ohio, Madison County, Somerford Township, VMS 3900, being part of a 37.7786 acre tract (Parcel 24-01022.000) conveyed to Neiswander Family Farms LLC by Official Record 99 page 1120, and being more particularly described as follows:

Beginning at a mag nail set in the centerline intersection of Arbuckle Road (County Road 110, 40 feet right-of-way) at the northeast corner of a 40.278 acre tract conveyed to Kenneth R Turner by Official Record 312 page 1822 and the northwest corner of said 37.7786 acre tract, said mag nail bears North 60° 44′ 58″ West a distance of 937.25 feet from a railroad spike found at the centerline intersection of Arbuckle Road and Gwynne Road (Township Road 111, right-of-way width unknown) and being the northeast corner of said 37.7786 acre tract;

Thence, with the centerline of Arbuckle Road, **South 60° 44′ 58" East** a distance of **577.19 feet** to a mag nail set;

Thence, across said 37.7786 acre tract with the following two new courses:

- 1) **South 26° 24' 23" West**, passing iron pin and cap set at 23.00 feet, a total distance of **1175.51 feet** to an iron pin and cap set;
- 2) North 52° 31′ 28″ West, passing a 5/8 inch diameter rebar and yellow plastic cap stamped "Clapsaddle RS#6140" found at a corner of said 40.278 acre tract at 244.99 feet, continuing with the line of said 40.278 acre tract, a total distance of 587.41 feet to a 5/8 inch diameter rebar and yellow plastic cap stamped "Clapsaddle RS#6140" found;

Thence, with the southeast line of said 40.278 acre tract, **North 26° 24′ 23″ East**, passing a 5/8 inch diameter rebar found at 1071.31 feet, a total distance of **1091.37 feet** returning to the **Point of Beginning**, containing **15.0000 Acres** more or less.

Beginning at a railroad spike found at the centerline intersection of Arbuckle Road (County Road 110, 40 feet right-of-way) and Gwynne Road (Township Road 111, right-of-way width unknown) and being the northeast corner of said 37.7786 acre tract;

Thence, with the centerline of Gwynne Road, **South 26° 42′ 15″ West** a distance of **2051.69 feet** to a 5/8 inch diameter rebar and yellow plastic cap stamped "Clapsaddle RS#6140" found at a corner to a 739.834 acre tract conveyed to Agricultural Lands LTD by Official Record 67 page 290 and being in the line between VMS 3900 and 5791;

Thence, with said 739.834 acre tract and said VMS line, **North 63° 46′ 04″ West**, passing the centerline of Gwynne Road and the Northeast corner of a 1.532 acre tract conveyed to Keith E Roberts and Violet L Roberts, Co-Trustees by Official Record 280 page 1228 at 25.70 feet, passing the Northeast corner of a 79.15 acre tract conveyed to Keith E Roberts and Violet L Roberts, Co-Trustees by Official Record 280 page 1228 and the Northeast corner of VMS 6244 at 144.54 feet, a total distance of **675.57 feet** to a 5/8 inch diameter rebar and yellow plastic cap stamped "Clapsaddle RS#6140" found at the southeast corner of a 40.278 acre tract conveyed to Kenneth R Turner by Official Record 312 page 1822;

Thence, with the southeast line of said 40.278 acre tract, **North 31° 37' 37" East** a distance of **947.04 feet** to a 5/8 inch diameter rebar and yellow plastic cap stamped "Clapsaddle RS#6140" found;

Thence, across said 37.7786 acre tract with the following two new courses:

- 1) South 52° 31' 28" East a distance of 244.99 feet to an iron pin and cap set;
- 2) North 26° 24′ 23″ East, passing iron pin and cap set at 1152.51 feet, a total distance of 1175.51 feet to mag nail set in the centerline of Arbuckle Road;
