Commencing at an iron pin found at the centerline intersection of Yankeetown-Chenoweth Road (County Road 9, 50 feet right-of-way) and Dyer Road (Township Road 66, 40 feet right-of-way);

Thence, with the centerline of Yankeetown-Chenoweth Road with the following four courses:

- 1) South 42° 05' 11" East a distance of 486.65 feet to a pony spike found;
- 2) South 42° 03' 27" East a distance of 963.13 feet to a PK nail and shiner found;
- 3) South 42° 02' 00" East a distance of 257.59 feet to a 1/4 inch diameter iron pin found;
- 4) South 49° 01′ 55″ East a distance of 369.75 feet to the Northeast corner of a 2.0002 acre tract conveyed to Stephen Douglas Anthony by Official Record 173 page 1773 and the Southwest corner of said 108.3317 acre tract and being the True Point of Beginning;
