11.0010 Acre Tract Surveyed for Anthony

The following described 11.0010 acre tract is situated in the State of Ohio, Madison County, Range Township, VMS 6824, being all of an 8.9945 acre tract (Parcel 21-00009.0__) conveyed to Stephen Douglas Anthony by Official Record ____ page ____ and all of a 2.0002 acre tract (Parcel 21-00009.004) conveyed to Stephen Douglas Anthony by Official Record 173 page 1773, and being more particularly described as follows:

Commencing at an iron pin found at the centerline intersection of Yankeetown-Chenoweth Road (County Road 9, 50 feet right-of-way) and Dyer Road (Township Road 66, 40 feet right-of-way);

Thence, with the centerline of Yankeetown-Chenoweth Road with the following two courses:

- 1) South 42° 05' 11" East a distance of 486.65 feet to a pony spike found;
- 2) South 42° 03' 27" East a distance of 963.13 feet to a PK nail and shiner found at the Southeast corner of an 81.9888 acre tract conveyed to Stephen R Anthony and Patricia J Anthony, Joint Lives by Official Record 82 page 958 and the Northeast corner of said 8.9945 acre tract and being the True Point of Beginning

Thence, continuing with the centerline of Yankeetown-Chenoweth Road with the following three courses:

- 1) South 42° 02' 00" East a distance of 257.59 feet to a 1/4 inch diameter iron pin found;
- 2) South 49° 01' 55" East, passing the Northeast corner of said 2.0002 acre tract at 369.75 feet, a total distance of 438.81 feet to a mag nail set over an iron pin found;
- South 49° 40' 46" East a distance of 247.39 feet to a mag nail set over an iron pin found at the Northeast corner of a 29.9946 acre tract conveyed to Mary L Roberts, TOD by Official Record 241 page 2116;

Thence, with the North line of said 29.9946 acre tract, **North 88° 55' 18" West**, passing an iron pin and cap set at 48.73 feet, passing a corner to said 8.9945 acre tract at 558.70 feet, a total distance of **879.67 feet** to a double angle iron fence post found at the Northeast corner of a 97.782 acre tract conveyed to James R Moats by Official Record 362 page 490;

Thence, with the North line of said 97.782 acre tract, **North 88° 38' 59" West** a distance of **263.76 feet** to an iron pin and cap set at the Southeast corner of a 17.3484 acre tract conveyed to Stephen R Anthony and Patricia J Anthony, Joint Lives by Official Record _____ page _____;

Thence, with the East line of said 17.3484 acre tract, **North 01° 47' 45" East** a distance of **616.66 feet** to an iron pin and cap set in the South line of said 81. 9888 acre tract;

Thence, with the South line of said 81.9888 acre tract, **South 89° 59' 46" East**, passing iron pin and cap set at 391.64 feet, a total distance of **431.45 feet** returning to the **True Point of Beginning**, containing **11.0010 Acres** more or less.

Bearings are based on the south line of a 42.3111 acre tract (North 89° 50' 06" West) as described in Official Record 336 page 185.

Subject to and with the benefit of all legal highways, restrictions, easements, limitations, and reservations, of record, if any and to zoning restrictions which have been imposed thereon, if any.

All iron pins set are 5/8-inch diameter rebar with yellow plastic cap stamped "Cottrill Surveying"
