0.3581 Acre Tract Surveyed for Crites

The following described 0.3581 acre tract is situated in the State of Ohio, Madison County, Village of Mount Sterling, VMS 6483 and VMS 12595, being part of Lot 16 (Parcel 18-00568.000) of Pleasant Ridge Addition Number 2 as recorded in Plat Book 2 page 79 and conveyed to Charlotte Crites by Official Record 357 page 861, and being more particularly described as follows:

Beginning at a 3/4 inch diameter iron pipe found in the northern line of the cul-de-sac (50 feet radius) of Mountview Court, being at the southeast corner of Lot 17 in the south corner of a 568 square feet tract conveyed to James E and Cynthia S Rolfe by Deed Book 282 page 201 and being the Southwest corner of said Lot 16, said pipe bears South 17° 33′ 33″ East a distance of 1952.61 feet from Madison County Monument 02-005;

Thence, with said 568 square feet tract with the following two courses:

- 1) North 14° 33′ 12″ West a distance of 37.21 feet to an iron pin and cap set;
- 2) North 24° 40′ 45″ West a distance of 80.07 feet to an iron pin and cap set at the east corner of a 0.297 acre tract conveyed to J & R Solid Rock Rentals LLC by Official Record 296 page 2239 and the south corner of a 0.457 acre tract conveyed to Jack E and Diana L Crawford by Deed Book 288 page 593;

Thence, with the southeast line of said 0.457 acre tract, **North 44° 27′ 43″ East**, passing an iron pin and cap set at 51.33 feet, a total distance of **61.33 feet** to the centerline of O'days Run and being the southwest corner of a 0.178 acre tract conveyed to John C and Ruth K Barnes, Joint Lives by Official Record 200 page 1493;

Thence, meandering with the centerline of O'days Run in the south line of said 0.178 acre tract with the following four courses:

- 1) South 83° 50′ 21" East a distance of 31.36 feet;
- 2) South 68° 17' 08" East a distance of 42.21 feet;
- 3) North 64° 02' 30" East a distance of 45.37 feet;
- 4) **South 89° 46' 52" East** a distance of **24.29 feet** to the northwest line of Lot 15 as conveyed to Dwana K Goodan by Official Record 45 page 574;

Thence, with the northwest line of Lot 15, **South 31° 04' 38" West**, passing an iron pin and cap set at 10.00 feet, a total distance of **167.56 feet** to an iron pin and cap set at the Northeast corner of a 36 square feet tract conveyed to Dwana K Goodan by Official Record 45 page 574;

Thence, around said 36 square feet tract with the following two courses;

- 1) North 58° 55′ 22″ West a distance of 3.00 feet to an iron pin and cap set;
- 2) **South 31° 04′ 38″ West** a distance of **12.35 feet** to an iron pin and cap set in the northern line of the cul-de-sac Mountview Court;

Thence, with the line of said cul-de-sac, with a curve to the left, **radius of 50.00 feet**, **arc length of 41.39 feet**, chord bears South 88° 53′ 12″ West a distance of 40.22 feet with a Delta angle of 47° 25′ 42″, returning to the **Point of Beginning**, containing **0.3581 Acres** more or less.

Bearings are based on the centerline of Columbus Street (North 19° 15′ East) as described in Official Record 2 page 1267.

Subject to and with the benefit of all legal highways, restrictions, easements, limitations, and reservations, of record, if any and to zoning restrictions which have been imposed thereon, if any.

All iron pins set are 5/8-inch diameter rebar with yellow plastic cap stamped "Cottrill Surveying"
