30.4076 Acre Tract Surveyed for Newport Crossing LLC

The following described 30.4076 acre tract is situated in the State of Ohio, Madison County, Range Township, Village of Midway, VMS 6050, being all of a 30.476 acre tract (Range Township Parcel 21-00140.000 and cap Village of Midway Parcel 22-00091.000) as conveyed to Joyce Tudor by Official Record 297 page 2675, and being more particularly described as follows:

Beginning at a mag nail set in the centerline of Main Street (State Route 38, 66 feet right-of-way) at the Northeast corner of a 1 acre tract conveyed to Dara L Barker by Official Record 268 page 1898 and the Southeast corner of said 30.476 acre tract, said mag nail bears North 00° 00 minute 06" East a distance of 832.15 feet from a railroad spike found at the centerline intersection of Main Street with The North Church Street;

Thence, with the North line of said 1 acre tract, **North 89° 20' 19" West**, passing an iron pin and cap set at 45.00 feet, a total distance of **228.44 feet** to a 6 inch diameter steel fence post found rusted off the grade in a line of a 96.10 acre tract conveyed to Wayne D Dixon, Trustee and JoAnn Dixon, Trustee by Official Record 56 pages 591 and 594;

Thence, with said 96.10 acre tract with the following three courses:

- 1) North 00° 03' 12" West, passing the corporate line of the Village of Midway at 73.16 feet, a total distance of 216.24 feet to a 6 inch diameter steel fence post found;
- North 89° 19' 18" West a distance of 1173.44 feet to a 1 inch square inside of a 2.5 inch steel post found;
- 3) North 00° 15' 44" West a distance of 1044.91 feet to the north side of a 2-feet by 1-foot concrete fence post found in the South line of a 262.529 acre tract conveyed to Chris D Jeffiers, TOD by Official Record 405 page 2101;

Thence, with the South line of said 262.529 acre tract, **South 89° 44' 44" East**, passing an iron pin and cap set at 10.00 feet, passing a 5/8 inch diameter rebar and orange plastic cap stamped "Sharrett-8019" found at 950.24 feet, a total distance of **983.06 feet** to a mag nail found in the centerline of State Route 38 (60 feet right-of-way);

Thence, with the centerline of State Route 38 with the following three courses:

- 1) South 24° 10' 48" East a distance of 1034.64 feet to a 1/2 inch diameter conduit found;
- 2) **South 00° 01' 24" West**, passing the corporate line of the Village of Midway at 253.73 feet, a total distance of **284.20 feet** to an iron pin found;
- 3) South 00° 02' 49" East a distance of 45.24 feet returning to the Point of Beginning, containing 30.4076 Acres more or less, of which 30.0173 acres more or less is in Range Township and 0.3903 acres more or less is in the Village of Midway.

Bearings are based on the centerline of Broad Street (South 89° 50' East) as shown on Slide 96 and 97, Count's Addition.

Subject to and with the benefit of all legal highways, restrictions, easements, limitations, and reservations, of record, if any and to zoning restrictions which have been imposed thereon, if any.

All iron pins set are 5/8-inch diameter rebar with yellow plastic cap stamped "Cottrill Surveying"
