

LEGAL DESCRIPTION

LaVern J. Yutzy, Trustee Of the Alice M. Yutzy Declaration of Trust 50.324 Acres Tract

Situated in the Township of Canaan, County of Madison, State of Ohio, being a part of V.M.S. No. 12743, and being all that remains (50.324 acres) of the original 51 acres "Tract I" (Parcel No. 01-00500.000) as conveyed to LaVern J. Yutzy, Trustee of the Alice M. Yutzy Declaration of Trust and recorded in Official Record 421, Page 2246 of the Madison County Recorder's Office, and being further bounded and described as follows:

Commencing at the centerline intersection of U.S. Route 42 and MV High Road (County Road No. 44);

thence with a commencement line S 84°52'34" E, a distance of 3681.11 feet to a railroad spike (found) in the centerline of MV High Road (County Road No. 44) marking the northeasterly corner of a 117.414 acres tract as conveyed to Andrew F. Thomas and Paula R. Thomas (O.R. 294, Page 636) and found in Survey Record CA-48 of the Madison County Engineer's Record of Land Surveys and being the true point of beginning of the tract of land herein described;

thence with the centerline of MV High Road for the next 4 calls:

1) S 85°08'16" E, a distance of 298.84 feet to a railroad spike (found);

- 2) S 83°24'52" E, a distance of 50.05 feet to a railroad spike (found);
- 3) S 83°34'25" E, a distance of 520.70 feet to a railroad spike (found);
- 4) S 83°34'04" E, a distance of 73.67 feet to a mag nail (found) marking the northwesterly corner of a 1.1523 acres tract as conveyed to James D. Johnson and Teressa J. Johnson (O.R. 207, Page 1) and found in Survey Record 34-00 of the Madison County Engineer's Record of Land Surveys;

thence with the westerly line of the aforesaid 1.1523 acres tract S 03°33'40" W passing a 5/8" iron pin (set) at 20.00 feet, a total distance of 194.19 feet to a 5/8" iron pin (found);

thence with the southerly line of the aforesaid 1.1523 acres tract S 83°59'31" E, a distance of 254.09 feet to a 5/8" iron pin (set) in the westerly line of a 48.9343 acres tract as conveyed to Marian D. Thomas, Trustee of the Frank F. Thomas Trust (O.R. 141, Page 28) and found in Survey Record 23-02 of the Madison County Engineer's Record of Land Surveys;

thence with the westerly line of the aforesaid 48.9343 acres tract S 07°05'47" W, a distance of 1649.95 feet to a 2" by 4" stone (found) marking a northeasterly corner of a tract of land referred to as "First Tract" as conveyed to Tom E. Straley (O.R. 236, Page 1575);

thence with the northerly line of the aforesaid tract of land referred to as "First Tract" N 84°54'40" W, a distance of 1209.06 feet to an 8" wood post (found) marking the southeasterly corner of the aforementioned 117.414 acres tract as conveyed to Andrew F. Thomas and Paula R. Thomas (O.R. 294, Page 635 and O.R. 294, Page 636) and found in Survey Record CA-48 of the Madison County Engineer's Record of Land Surveys;

thence with the easterly line of the aforesaid 117.414 acres tract N 07°04'31" E passing a T-Rod (found) at 1843.13 feet, a total distance of 1862.26 feet to the true point of beginning, containing 50.324 acres of land.

Subject to all legal easements and rights-of-way of record.

Bearings are based upon the Grid Azimuth (AZ. 289° 46′ 16.0″) between National Geodetic Survey CORS Station "COLB" and McCarty Associates Geodetic Local Survey Control Monument "2001" and derived from GPS observations taken December 8, 2023, utilizing the ODOT Ohio Real Time Network (Trimble Virtual Reference System).

Land surveyed in December 2023 and January 2024, under the direction of Jason C. McConnaughey, Registered Professional Surveyor No. 8509, the survey plat of which is referred to as Project No. S23-377B on file in the office of McCarty Associates, LLC, Hillsboro, Ohio.

All iron pins (set) are 5/8" diameter with 1-1/4" diameter plastic caps stamped "McCARTY ASSOCIATES".
