

BEGINNING at a set 5/8" rebar with cap on the northwesterly line of Virgina Military Survey Number, (VMS), 7074, and being a point on the northwesterly line of a 251.8835 acre tract as conveyed to William C. Moler in Official Record Volume 384, Page 2494, (Madison County), said point being North 57°45'34" East, 881.61 feet from the northwest corner of a found concrete post marking the southwesterly corner of said VMS 7074;

Thence departing said northwesterly line of VMS 7074, and with a New Line of Division, **North 32°14'26'' West, 645.02 feet**, to a set 5/8'' rebar with cap, being on the southeasterly line of a 68.40 acre tract as conveyed to PCGreenSquare, LTD in O.R. 421 Page 2157, (Madison County);

Thence with the said southeasterly line of the 68.40 acre tract and southeasterly line of a 23.51 acre tract of land as conveyed to PCGreenSquare, LTD in Instrument Number 202402020000740, (Union County), North 57°45'30" East, 1986.18 feet to a found 5/8" rebar, being on the southwesterly line of the railroad as conveyed to New York Central Lines, LLC in O.R Book 207 Page 45, (Union County);

Thence with the southwesterly line of said Railroad and with the southwesterly line of a 5.04 acre tract as conveyed to New York Central Lines, LLC in O.R. 106 Page 703, **South 39°15'42'' East, 649.94 feet** to a found 5/8'' rebar, being the northeasterly corner of said 251.8835 acre tract;

Thence with the northwesterly line of said 251.8835 acre tract, **South 57°45'34" West, 2065.63 feet** to the **POINT OF BEGINNING** and containing **30.000 acres** more or less and having 29.820 acres more or less in Madison County Ohio, of which 29.75 acres more or less are within VMS 5167 and 0.25 acre more or less being within VMS 7074, and having 0.180 acre more or less within Union County Ohio.

Moler in Official Record Volume 384, Page 2494, said point being North 57°45'34" East, 203.93 feet from a found concrete post marking the southwesterly corner of said VMS 7074;

Thence departing said northwesterly line of VMS 7074, and along the northeasterly line of a 3.427 acre tract of land as conveyed to Ricky Dean Tidd in Official Record Volume 355, Page 2503, North 32°16'00" West, 213.72 feet, to a set 5/8" rebar with cap;

Thence with the northwesterly line of said 3.427 acre tract, **South 57°46'43'' West, 204.08 feet** to a found 5/8'' rebar, being the easterly corner of a 2.894 acre tract of land as conveyed to USA Sportz, LLC in Official Record Volume 414, Page 1292;

Thence with the northeasterly line of said 2.894 acre tract, North 32°12'56" West, 147.16 feet to a set 5/8" rebar with cap:

Thence with the northwesterly line of said 2.894 acre tract, **South 57°45'30'' West, 606.71 feet** to a point in the centerline of State Route 161, (80' ROW), passing a found 5/8'' rebar at 557.86 feet;

Thence with the centerline of State Route 161, **North 66°05'52" West, 60.00 feet** to a point, said point having for reference a found 5/8" rebar 48.16 feet along the following course, said point being the southerly corner of a 6.00 acre tract as conveyed to USA Sportz, LLC in Official Record Volume 401, Page 2159;

Thence departing said centerline of State Route 161 and with the southeasterly line of said 6.00 acre tract, North 57°46'31" East, 876.30 feet to a set 5/8" rebar with cap;
