LEGAL DESCRIPTION

John J. Emrich and Lisa G. Emrich 62.339 Acres Tract

Situated in the Townships of Paint and Stokes, County of Madison, State of Ohio, being a part of V.M.S. Nos. 3983 and 8672, and being a part of what remains of the original 117.84 acres tract (Paint Twp. Parcel No. 14-00093.000 and Stokes Twp. Parcel No. 27-00054.000) as conveyed to John J. Emrich and Lisa G. Emrich and recorded in Official Record 296, Page 206 of the Madison County Recorder's Office, and being further bounded and described as follows:

Commencing at the intersection of Linson Road (County Road No. 17) and Foody Road (Township Road No. 87);

thence with the centerline of Foody Road S 03°51'15" W, a distance of 3088.09 feet to an angle point;

thence continuing with the centerline of Foody Road S 05°32'45" W, a distance of 984.06 feet to a railroad spike (found) marking the southeasterly corner of a 19.40 acres tract as conveyed to James Carson Mitchell and Monica M. Mitchell (O.R. 421, Page 454) and found in Survey Record 36-05 of the Madison County Engineer's Record of Land Surveys, said railroad spike being the true point of beginning of the tract of land herein described;

thence with the centerline of Foody Road S 05°31'43" W, a distance of 648.76 feet to a 3/4" iron pipe (found);

thence continuing with the centerline of Foody Road S 05°44'54" W, a distance of 819.10 feet to a railroad spike (found) marking the northeasterly corner of a 5.1311 acres tract as conveyed to James Detrow and Wanda Detrow (O.R. 416, Page 2333) and found in Survey Record 50-98 of the Madison County Engineer's Record of Land Surveys;

thence with the northerly line of the aforesaid 5.1311 acres tract N $86^{\circ}05'25"$ W passing a 5/8" iron pin (found) at 24.90 feet, a total distance of 745.70 feet to a 5/8" iron pin (found);

thence with the westerly line of the aforesaid 5.1311 acres tract S 05°38'03" W, a distance of 300.31 feet to a point, from which a 3/4" iron pipe (found, bent) bears N 24°32'15" E, a distance of 0.39 feet, said pint being in a northerly line of a 58.1840 acres tract as conveyed to Marilyn J. Hughes (O.R. 251, Page 1418) and found in Survey Record 38-09 of the Madison County Engineer's Record of Land Surveys;

thence with a northerly line of the aforesaid 58.1840 acres tract N 86°07'00" W, a distance of 673.85 feet to a double angle iron post (found) in an easterly line of what remains of an original 1024.455 acres tract as conveyed to Indian Run Aglands LLC (O.R. 261, Page 641);

thence with a easterly line of what remains of the aforesaid original 1024.455 acres tract N 11°09'47" W, a distance of 1197.38 feet to a double angle iron post (found) marking the southeasterly corner of a 62.67 acres "Property 1, Tract 2" as conveyed to Heiner Gantenbrink Farms (O.R. 105, Page 562 and O.R. 256, Page 1091);

thence with the easterly line of the aforesaid 62.67 acres "Property 1, Tract 2" N 02°32'08" W, a distance of 605.03 feet to a 3/4" iron pipe (found) marking the southwesterly corner of the aforementioned 19.40 acres tract as conveyed to James Carson Mitchell and Monica M. Mitchell (O.R. 421, Page 454) and found in Survey Record 36-05 of the Madison County Engineer's Record of Land Surveys;

thence with the southerly line of the aforesaid 19.40 acres tract S 86°24'30" E passing a 5/8" iron pin (set) at 1827.51 feet, a total distance of 1852.51 feet to the true point of beginning, containing 62.339 acres of land, of which 59.460 acres being within the Township of Paint and 2.879 acres being within Stokes Township.

in Survey Record 50-98 of the Madison County Engineer's Record of Land Surveys;

Emrich and recorded in Official Record 296, Page 206 of the Madison County Recorder's Office, and being further bounded and described as follows:

Commencing at the intersection of Linson Road (County Road No. 17) and Foody Road (Township Road No. 87);

thence with the centerline of Foody Road for the next three calls:

- 1) S 03°51'15" W, a distance of 3088.09 feet to an angle point;
- 2) S 05°32'45" W, a distance of 984.06 feet to a railroad spike (found);
- 3) S 05°31'43" W, a distance of 648.76 feet to a 3/4" iron pipe (found) marking the southwesterly corner of a 55.68 acres tract as conveyed to Waters Family, LLC (O.R. 128, Page 1145), said pipe being the true point of beginning of the tract of land herein described;
