Beginning at a mag nail set in the centerline of Finley-Guy Road (County Road 123, 50 feet right-of-way) at the Northwest corner of a 2.721 acre tract conveyed to Croplands LLC by Official Record 417 page 1558 and a corner to said 103.601 acre tract, said mag nail bears South 40° 23′ 53″ East a distance of 516.51 feet from the intersection of the centerline of Finley-Guy Road with the Pike/Monroe Township line;
