The following described 6.3427 acre tract is situated in the State of Ohio, Madison County, Jefferson Township, VMS 2682, being part of a 34.08 acre tract (Parcel 08-00842.000, Tract One) conveyed to Ralph G Rohner, Jr, Successor Trustee of the Karen E Rohner Trust dated March 15, 1981, Trust B by Official Record 294 page 109, and being more particularly described as follows:

Commencing at an iron pin found at the centerline intersection of Taylor Blair Road (County Road 14, 50 feet right-of-way and Fayette Drive (50 feet wide);

Thence, with the centerline of Taylor Blair Road, South 44° 16' 12" East a distance of 625.18 feet to a mag nail set over an iron pin found at the East corner of Lot 1 of Taylor Blair Estates as recorded in Plat Book 2 page 227 and the North corner of said 34.08 acre tract and being the **True Point of Beginning**;

Thence, continuing with the centerline of Taylor Blair Road, **South 44° 23' 41" East** a distance of **417.33 feet** to a mag nail set in the centerline of a ditch;

Thence, with an open ditch across said 34.08 acre tract with the following seven new courses:

- 1) South 64° 38' 07" West, passing an iron pin and cap set at 28.67 feet, a total distance of 59.61 feet to a point;
- 2) South 54° 30' 53" West a distance of 111.54 feet to a point;
- 3) South 74° 00' 11" West a distance of 54.74 feet to a point;
- 4) North 70° 25' 55" West a distance of 39.59 feet to a point;
- 5) South 74° 24' 56" West a distance of 63.58 feet to a point;
- 6) South 89° 32' 21" West a distance of 70.77 feet to a point;
- 7) South 74° 05' 06" West a distance of 53.96 feet to a point;

Thence, across said 34.08 acre tract with the following two new courses:

- Leaving said ditch, South 45° 36' 20" West, passing an iron pin and caps set at 10.00 feet and 337.91 feet, a total distance of 378.88 feet to a point near the bank of a creek;

Commencing at an iron pin found at the centerline intersection of Taylor Blair Road (County Road 14, 50 feet right-of-way and Fayette Drive (50 feet wide);

Thence, with the centerline of Taylor Blair Road with the following two courses:

- 1) South 44° 16′ 12″ East a distance of 625.18 feet to a mag nail set over an iron pin found at the North corner of said 34.08 acre tract;
- South 44° 23′ 41″ East a distance of 827.97 feet to a mag nail set at the True Point of Beginning;

Thence, across said 34.08 acre tract with the following three new courses:

- 1) South 50° 51' 33" West, passing iron pin and caps set at 29.54 feet and 464.46 feet, a total distance of **725.46 feet** to an iron pin and cap set;
- 2) North 48° 50′ 41″ West, passing the East line of said 22.926 acre tract at 67.08 feet, continuing across said 22.926 acre tract, passing the line common to said 34.08 acre tract at 522.74 feet, continuing across said 34.08 acre tract, a total distance of 549.65 feet to a point near the bank of a creek;

The following described 2.4023 acre Easement is situated in the State of Ohio, Madison County, Jefferson Township, VMS 2682, being part of a 34.08 acre tract (Parcel 08-00842.000, Tract One) and part of a 22.926 acre tract (Parcel 08-00842.000, Tract Two) both conveyed to Ralph G Rohner, Jr, Successor Trustee of the Karen E Rohner Trust dated March 15, 1981, Trust B by Official Record 294 page 109, and being more particularly described as follows:

Commencing at an iron pin found at the centerline intersection of Taylor Blair Road (County Road 14, 50 feet right-of-way and Fayette Drive (50 feet wide);

Thence, with the centerline of Taylor Blair Road with the following two courses:

- 1) South 44° 16′ 12″ East a distance of 625.18 feet to a mag nail set over an iron pin found at the North corner of said 34.08 acre tract;
- 2) South 44° 23' 41" East a distance of 827.97 feet to a mag nail set

Thence, across said 34.08 acre tract, South 50° 51′ 33″ West a distance of 725.46 feet to an iron pin and cap set at the **True Point of Beginning**;

Thence, across said 34.08 acre tract, **North 48° 50' 41" West**, passing the line between said 34.08 acre tract and 22.926 acre tract at 67.08 feet and again at 522.74 feet, a total distance of **605.11 feet** to a point in the 910' contour line;

Thence, continuing across said 34.08 acre tract and with said 910' contour line with the following six courses:


- 1) South 74° 44' 44" East a distance of 71.54 feet to a point;
- South 83° 49' 33" East, passing an iron pin and cap set at 67.59 feet, a total distance of 195.26 feet to an iron pin and cap set;
- 3) South 77° 38' 10" East a distance of 114.18 feet to an iron pin and cap set;
- 4) South 68° 23' 21" East a distance of 146.74 feet to an iron pin and cap set;
- 5) South 53° 35' 02" East a distance of 159.06 feet to an iron pin and cap set;
- 6) South 42° 25' 22" East a distance of 28.09 feet to an iron pin and cap set;

Thence, leaving said 910' contour and continuing across said 34.08 acre tract, **South 50° 51' 33" West** a distance of **261.00 feet** returning to the **True Point of Beginning**, containing **2.4023 Acres** more or less, of which 1.6025 acres more or less is part of said 34.08 acre tract and 0.7998 acres more or less is part of said 22.926 acre tract.
