The following described 0.2248 acre tract is situated in the State of Ohio, Madison County, City of London, VMS 8742, being the northeast one half of a 0.4450 acre tract (Parcel 31-02935.000) conveyed to Carolyn A Wickline by Official Record 184 page 1223, and being more particularly described as follows:

Beginning at an iron pin and cap set in the Northwest line of Mound Street (50 feet wide) at the South corner of an alley of unknown width (as described in Richard and Cindy Wiggins deed as recorded in Official Record 414 page 91) and the East corner of said 0.4450 acre tract, said iron pin and cap bears North 57° 00′ 00″ East a distance of 471.19 feet from a T-bar found at the intersection of the Northwest line of Mound Street with the Northeast line of Olive Street (50 feet wide);

Thence, with the Northwest line of Mound Street, **South 57° 00' 00" West** a distance of **68.00 feet** to an iron pin and cap set;

Thence, with a new line across said 0.4450 acre tract, **North 31° 29′ 23″ West** a distance of **144.06 feet** to an iron pin and cap set in the Southeast line of a 3.7882 acre tract conveyed to Carolyn A Wickline by Official Record 184 page 1223;

Thence, with the Southeast line of said 3.7882 acre tract, **North 57° 00′ 04″ East**, passing an iron pin and cap set at 63.00 feet, a total distance of **68.00 feet** to 4 inch square wood fence post found at the West corner of said alley;

Thence, with the Southwest line of said alley, **South 31° 29′ 23″ East**, passing an iron pin and cap set at 5.00 feet, a total distance of **144.06 feet** returning to the **True Point of Beginning**, containing **0.2248 Acres** more or less.

Beginning at an iron pin and cap set in the Northwest line of Mound Street (50 feet wide) at the East corner of a 0.3972 acre tract conveyed to Carolyn A Wickline by Official Record 184 page 1223 and the South corner of said 0.4450 acre tract, said iron pin and cap bears North 57° 00′ 00″ East a distance of 335.19 feet from a T-bar found at the intersection of the Northwest line of Mound Street with the Northeast line of Olive Street (50 feet wide);

Thence, with the Northeast line of said 0.3972 acre tract, **North 31° 29′ 23″ West** a distance of **144.06 feet** to an iron pin and cap set in the Southeast line of a 3.7882 acre tract conveyed to Carolyn A Wickline by Official Record 184 page 1223;

Thence, with the Southeast line of said 3.7882 acre tract, **North 57° 00′ 04″ East** a distance of **68.00 feet** to an iron pin and cap set;
