## **2.5000 Acre Tract** Surveyed for Curry

The following described 2.5000 acre tract is situated in the State of Ohio, Madison County, Jefferson Township, VMS 10689, being part of a 213.778 acre tract (Parcel 08-00613.000, 216.278 original acres) conveyed to Robert F Schafer, Trustee of the Sidney K Schafer Revocable Living Trust by Official Record 315 page 2581, and being more particularly described as follows:

Commencing at an iron pin found at the centerline intersection of Wilson Road (County Road 103, 50 feet right-of-way) and Gregg Road (County Road 43);

Thence, with the centerline of Wilson Road with the following three courses:

- 1) North 02° 13′ 12″ East a distance of 19.34 feet to a railroad spike found;
- 2) North 60° 55′ 05″ East a distance of 921.12 feet to a railroad spike found;
- 3) North 39° 49′ 33" East a distance of 123.20 feet to a mag nail found;
- 4) North 45° 58′ 23″ East a distance of 153.65 feet to a mag nail found in the Northwest line of VMS 10698 and being a corner to VMS 10505 and VMS 10585;
- 5) with the line between VMS 10698 and 10505, North 60° 13′ 23″ East a distance of 71.35 feet to a mag nail found at the north corner of a 2.5000 acre tract conveyed to Robyn R and Scott D Curry, Joint Lives by Official Record 411 page 1560, a corner to said 213.778 acre tract and being the **True Point of Beginning**;

Thence, continuing with the centerline of Wilson Road and said VMS line, **North 60° 13′ 23″ East** a distance of **213.69 feet** to a mag nail set;

Thence, across said 213.778 acre tract with the following two new courses:

- 1) **South 29° 18′ 34″ East**, passing an iron pin and cap set at 20.00 feet, a total distance of **510.52 feet** to an iron pin and cap set and buried 1 foot deep;
- 2) **South 60° 41' 26" West** a distance of **213.68 feet** to an iron pin and cap previously set at the east corner of said Curry's 2.5000 acre tract;

Thence, with the Northeast line of said 2.5000 acre tract, **North 29° 18′ 34″ West**, passing an iron pin and cap previously set at 489.25 feet, a total distance of **508.77 feet** returning to the **True Point of Beginning**, containing **2.5000 Acres** more or less.

Bearings are based on a GPS observation on August 6, 2018, WGS 1984 Geodetic North.

This deed is subject to and with the benefit of all legal highways, restrictions, easements, limitations, and reservations, of record, if any and to zoning restrictions which have been imposed thereon, if any.

All iron pins set are 5/8-inch diameter rebar with yellow plastic cap stamped "Cottrill Surveying"
