




0.3955 Acre Tract *Surveyed for Sharrett*

The following described 0.3955 acre tract is situated in the State of Ohio, Madison County, Pleasant Township, VMS 8207, being part of a 23.9699 acre tract (Parcel 17-00466.001) conveyed to Charles A and Courtney Lynn Bricker, Joint Lives by Official Record 405 page 679, and being more particularly described as follows:

Commencing at a monument box found at the centerline intersection of Robinson Road (County Road 62, 45 feet right-of-way) and State Route 56 (60 feet right-of-way);

Thence, with the centerline of State Route 56 with the following three courses:

- 1) South 20° 07' 12" East a distance of 1081.42 feet;
- 2) South 19° 36' 47" East a distance of 1039.31 feet to a mag nail set;
- 3) South 4° 05' 05" East a distance of 196.04 feet to the Southeast corner of a 0.9972 acre tract conveyed to Richard F Sharrett, II by Official Record 417 page 1593 and a corner to said 23.9699 acre tract;

Thence, with the Southeast line of said 0.99972 acre tract, South 54° 21' 06" West, passing 1/2 inch diameter iron pin found at 36.85 feet, a total distance of 241.33 feet to a 1/2 inch diameter iron pin found at the South corner of said 0.99972 acre tract and being the **True Point of Beginning**;

Thence, across said 23.9699 acre tract with the following two new courses;

- 1) **South 54° 21' 06" West** a distance of **103.00 feet** to an iron pin and cap set;
- 2) **North 35° 35' 25" West** a distance of **167.27 feet** to a railroad spike set in the Southeast line of a 3.9994 acre tract conveyed to Jerry Quarles by Official Record 436 page 1619;

Thence, with said 3.9994 acre tract with the following two courses:

- 1) **North 54° 22' 55" East** a distance of **103.00 feet** to a railroad spike set;
- 2) **South 35° 35' 25" East**, passing a railroad spike set at the Northwest corner of said 0.99972 acre tract at 15.01 feet, a total distance of **167.22 feet** returning to the **True Point of Beginning**, containing **0.3955 Acres** more or less.

Ingress/Egress Easement Surveyed for Bricker

The following described Ingress/Egress Easement is situated in the State of Ohio, Madison County, Pleasant Township, VMS 8207, being part of a 23.9699 acre tract (Parcel 17-00466.001) conveyed to Charles A and Courtney Lynn Bricker, Joint Lives by Official Record 405 page 679, and being more particularly described as follows:

Commencing at a mag nail set at a PI in State Route 56 (60 feet right-of-way), being a corner common to Scioto Farm Units 44 and 43, said mag nail bears South 20° 07' 12" East a distance of 1081.42 feet and South 19° 36' 47" East a distance of 1039.31 feet from a monument box found at the centerline intersection of Robinson Road (County Road 62, 45 feet right-of-way) and State Route 56;

Thence, with the tangent of centerline, South 04° 05' 05" East a distance of 17.61 feet to a mag nail set at the North corner to a 0.99972 acre tract conveyed to Richard F Sharrett, II by Official Record 417 page 1593 and the East corner of a 3.9994 acre tract conveyed to Jerry Quarles by Official Record 436 page 1619;

Thence, with the Northwest line of said 0.99972 acre tract, South 54° 22' 55" West a distance of 334.58 feet to a railroad spike set at the West corner of said 0.99972 acre tract, in a line to said 23.9699 acre tract and being the **True Point of Beginning**;

Thence, across said 23.9699 acre tract with the following two courses;

- 1) **South 54° 22' 55" West** a distance of **103.00 feet** to a point;
- 2) **North 35° 35' 25" West** a distance of **15.01 feet** to a railroad spike set in the Southeast line of said 3.9994 acre tract;

Thence, with said 3.9994 acre tract with the following two courses:


- 1) **North 54° 22' 55" East** a distance of **103.00 feet** to a railroad spike set;
- 2) **South 35° 35' 25" East** a distance of **15.01 feet** returning to the **True Point of Beginning**, containing **0.0355 Acres** more or less.
