LEGAL DESCRIPTION

PARCEL 1

October 15, 2024

Situated in the Township of Pike, County of Madison, State of Ohio, being a part of Virginia Military Survey (VMS) 12131, 12132, 12133 & 4939 (Parcel 15-00070.000) and being a record 345.77-acre parcel conveyed to Eileen M. Keller, Trustee of the Eileen M. Keller Revocable Trust UAD October 23, 1997 by official record volume 312, page 1517 of the Madison County Recorder's records and being more particularly described as follows:

Commencing at a 1" iron bar found in monument box marking the intersection of the centerline of Rosedale Plain City Road-(TR 24)(60' R/W) with the centerline of State Route 38, being referenced by County Monument 12-45 found North 61 degrees 08 minutes 19 seconds West, 76.68 feet, therefrom;

Thence, North 01 degree 33 minutes 40 seconds West, 1033.89 feet along said centerline of State Route 38 to a railroad spike set in an interior corner of a record 246.685-acre parcel conveyed to Fair Acres Farm on the Darby, LLC. by official record volume 410, page 1632, and being the **Place of Beginning** of the parcel herein described;

Thence, the following courses:

- 1. South 84 degrees 08 minutes 18 seconds West, 1938.44 feet along a north line of said 246.685-acre Fair Acres Farm on the Darby, LLC. parcel to an iron pin found in the southwest corner of VMS 4939, also being a corner of said VMS 6965, and being on the centerline of Rosedale Plain City Road-(60' R/W);
- 2. **South 84 degrees 31 minutes 49 seconds West, 1408.42 feet** along a southerly line of VMS 12131, 12132 and 12133, also being along said centerline of Rosedale Plain City Road to a railroad spike found in a southeast corner of a record 341.876-acre parcel conveyed to Miley Farms, LLC. by official record volume 387, page 2061;
- 3. North 11 degrees 54 minutes 20 seconds East, 4123.95 feet along the east line of said Miley Farms, LLC. parcel and along an east line of a record 765.40-acre parcel conveyed to Stewart Farm, Inc. by official record volume 184, page 329 to an iron pin set in an interior corner of said Stewart Farm, Inc. parcel, passing through iron pins found for reference at 30.05 feet and 2755.33 feet respectively;
- 4. **South 86 degrees 11 minutes 57 seconds East, 2387.19 feet** along a south line of said Stewart Farm, Inc. parcel to an iron pin set in an interior corner thereof, and being the northwest corner of said VMS 4939;

- 5. **South 73 degrees 34 minutes 03 seconds East, 2801.09 feet** along the north line of VMS 4939, also being a south line of said Stewart Farm, Inc. parcel and the south line of a 98.02-acre parcel conveyed to Fair Acres Farm on the Darby, LLC. by official record volume 410, page 1632 to a point in the northeast corner of VMS 4939, being in the center of the Little Darby Creek, passing through a Magnail spike found for reference at 75.84 feet, in the aforementioned centerline of State Route 38, and an iron pin set for reference at 2751.09 feet;
- 6. Along the east line of VMS 4939, also being the center of Little Darby Creek, the following **SEVEN** courses:
 - 5.1. South 22 degrees 43 minutes 19 seconds West, 90.16 feet;
 - 5.2. South 71 degrees 56 minutes 16 seconds West, 803.65 feet;
 - 5.3. South 69 degrees 07 minutes 51 seconds West, 328.74 feet;
 - 5.4. South 74 degrees 48 minutes 47 seconds West, 201.12 feet;
 - 5.5. South 29 degrees 41 minutes 24 seconds West, 490.42 feet;
 - 5.6. South 13 degrees 25 minutes 39 seconds West, 877.34 feet;
 - 5.7. **South 02 degrees 24 minutes 32 seconds West, 982.77 feet** to a point in a northeast corner of the aforementioned record 246.685-acre parcel conveyed to Fair Acres Farm on the Darby, LLC. by official record volume 410, page 1632;
- 7. **North 89 degrees 12 minutes 37 seconds West, 801.07 feet** along a north line of said 246.685-acre parcel to the **Place of Beginning**, passing through an iron pin set for reference at 58.00 feet, and containing 346.3428 acres, more or less, and subject to all legal highways, leases, servitudes, use restrictions, and easements of record.

North 19 degrees 28 minutes 36 seconds East, 2488.63 feet along an easterly line of said Woodland Farms, Inc. parcel to a 2" Magnail spike set in a northeast corner thereof, said spike also being on a northerly line of the aforementioned VMS 6965, being on the aforementioned centerline of Rosedale Plain City Road, and passing through an iron pin set for reference at 2458.63 feet;
- 5. South 78 degrees 36 minutes 31 seconds East, 445.83 feet along said northerly line of VMS 6965, said centerline of Rosedale Plain City Road, to an iron pin found marking a point of deflection;
- 6. North 84 degrees 39 minutes 16 seconds East, 478.44 feet continuing along a northerly line of VMS 6965, said centerline of Rosedale Plain City Road, to a railroad spike found at a point of deflection;

North 84 degrees 31 minutes 49 seconds East, 633.25 feet continuing along a northerly line of VMS 6965, said centerline of Rosedale Plain City Road, to the Place of Beginning, and containing 106.1664 acres, more or less, and subject to all legal highways, leases, servitudes, use restrictions, and easements of record.
