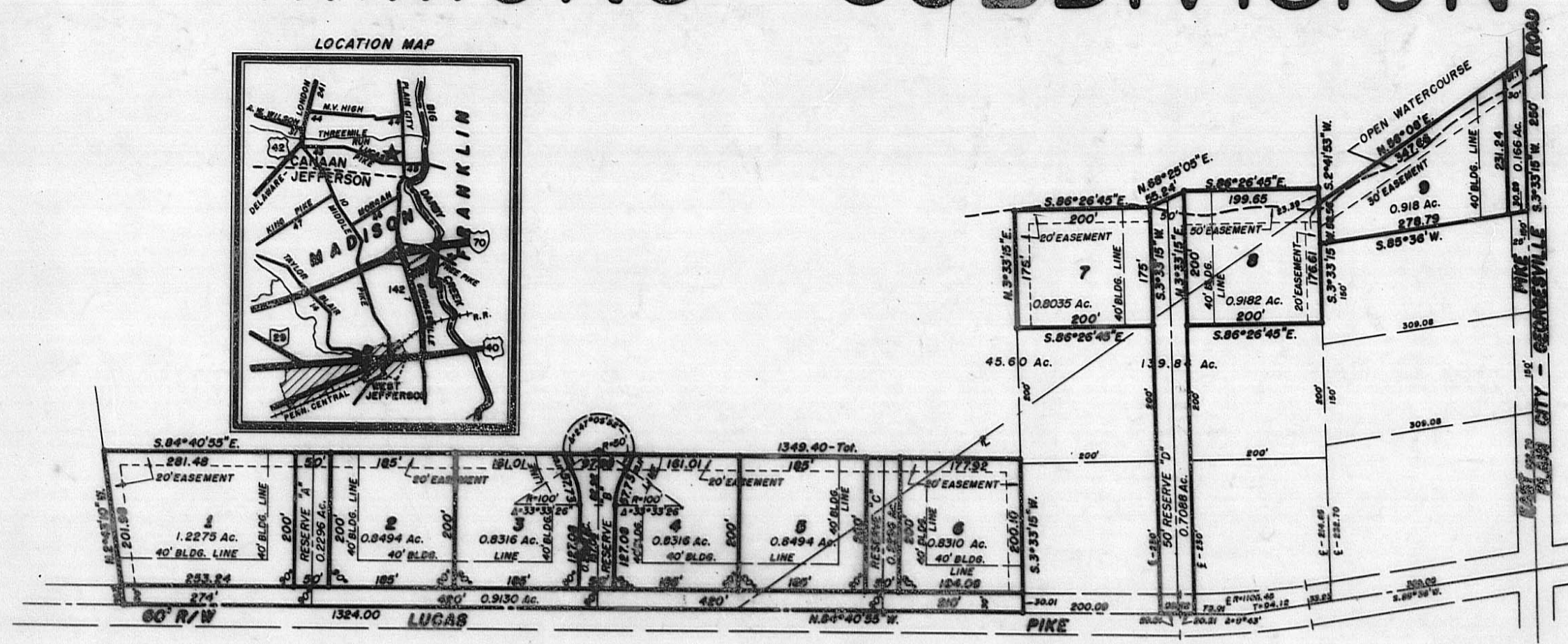


TIMMONS SUBDIVISION



We, the undersigned, Ben H. Timmons and Anna W. Timmons owners of 9.4884 Acres and Roman Y. Lapp and Nancy E. Lapp owners of 1.084 Acres, all in the Township of Canaan, County of Madison, State of Ohio, being a part of V.M.S. No. 2681, do hereby certify and accept the attached plat as a true and correct representation of our subdivision, TIMMONS SUBDIVISION, into lots of the premises herein described.

The above mentioned 9.4884 Acres being part of the FIRST PARCEL, 139.84 Acres and part of the SECOND PARCEL, 45.60 Acres as conveyed to Ben H. Timmons and Anna W. Timmons by deed of record in Vol. 182, Page 445, and the above mentioned 1.084 Acre Tract being all of the land conveyed to Roman Y. Lapp and Nancy E. Lapp by deed of record in Vol. 183, Page 216, all of record in the Madison County Recorder's Office.

The undersigned being all the owners and lien holders of the lands herein platted further agrees that any use or improvements made on this land shall be in conformity with all existing valid zoning, platting, health or other lawful rules and regulations of Madison County, Ohio, for the benefit of themselves and all other subsequent owners or assigns taking title from, under or through the undersigned.

The dimensions of the lots and street are shown on the plat in feet and decimal parts thereof. Easements shown on this plat are for the construction, operation, maintenance, repair, replacement or removal of water, sewer, gas, electric, telephone, or other utility lines or services, and for the express privilege of removing any and all trees or other obstructions to the free use of said utilities and for providing ingress and egress to the property for said purposes and are to be maintained as such forever. Easements are reserved where indicated on the plat for public utility purposes above and beneath the surface of the ground. Dashed lines shown marked BLDG. LINE indicates the minimum distance buildings must be set back from the roads and RESERVES, RESERVES A, B, C, D are for such uses as shall hereafter be determined. **LOT 9 GRANTS AN EASEMENT ONLY FOR THE TILE INSTALLATION, MAINTENANCE AND REPAIR OF THE TILE THEREIN.**

The said Ben H. Timmons and Anna W. Timmons being the owners of Lots 1 through Lot 8, and the 4 RESERVES, and the said Roman Y. Lapp and Nancy E. Lapp being the owners of Lot 9.
