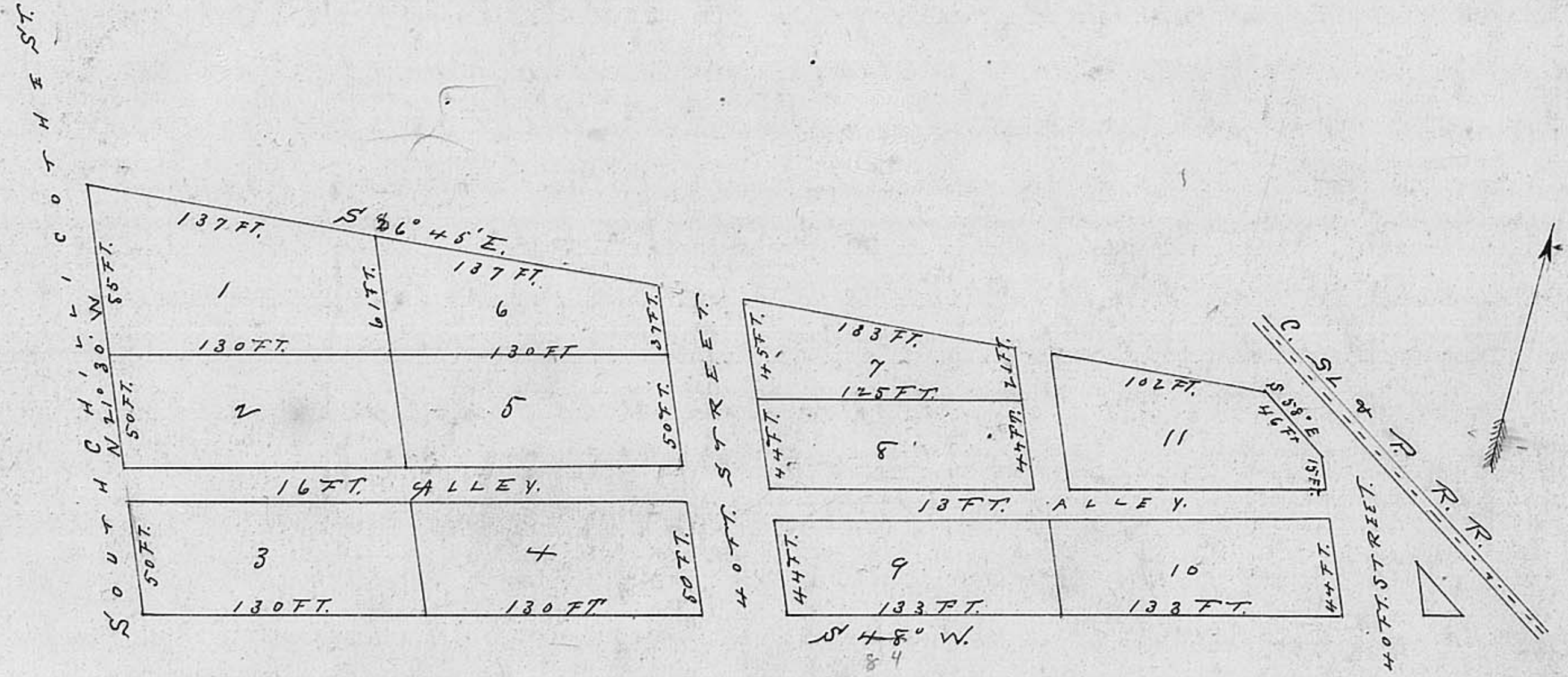


Andrews Addition to Plain City, is Located on the East side of South Chillicothe St. and is predicated upon a Stone at the N. W. corner of Sherwoods first addition to Plain City. The west line of this addition beginning at said Stone in Sherwoods addition runs N 21° 30'. The N line runs S 86° 45' E. The East line adjoining the Rail Road runs S 58° E. and the South line adjoining Sherwoods Addition runs S 84° W. Lot No 1 is 85 ft front, 61 ft on the East end, 130 feet on the S line and 137 ft on the N. line. Lots No 2, 3, 4 & 5 are each 50 ft in width and 130 ft in length. Lot No 6 is 61 ft on the west end, 37 ft on the East, 130 ft on the South and 137 ft on the N. line. Lot No 7 fronting a 40 foot St is 45 feet in front, 21 ft on the back end, 125 ft on the South and 133 ft on the N. line. Lot No 8 is 44 ft in width and 125 ft in length. Lots No 9 & 10 each fronting a 40 ft street are each 44 ft in width and 133 ft in length. Lot No 11 fronting a 40 ft street is 15 ft in front, 46 ft adjoining the Rail Road, 102 ft on the N 62 feet on the W. and 125 ft on the S. The alley between Lots 2, 3, 4 & 5 is 16 ft in width. The Alley between Lots No 8, 9, 10 & 11 running east and west is 13 ft in width. The Alley between Lots No 7, 8 & 11 is 16 ft in width. Lots No 1, 2, & 3 front on Chillicothe St. Lots No 4, 5, 6, 7, 8, 9, 10 & 11 front on a 40 ft street. Surveyed Feb. 1888. J. Converse surveyor. (Lucy A Andrews, heirs)

Know all men by these presents that W. P. Andrews, and Mary G Andrews his wife; Charles Mead Andrews and Lyman S Andrews, all of Plain City Madison Co. 




