Beginning at an iron pin in the north line of Town St. comes to
 P. C. Gregg - thence with said line S 87° W 559 feet to an iron pin; thence
 S 3° W 553 feet to an iron pin on the south bank of Little Blarby creek;
 thence with two lines thereof S 48° 15' E 89 1/2 feet to a stake; thence S 40°
 E 140 1/2 feet to a red oak; thence S 31° 50' E 1813 feet to the beginning
 containing 5.58 acres of land. Being part of survey No 2836, located in
 the village of Jefferson Madison Co Ohio and now owned by James Slaven.

 public use forever.


