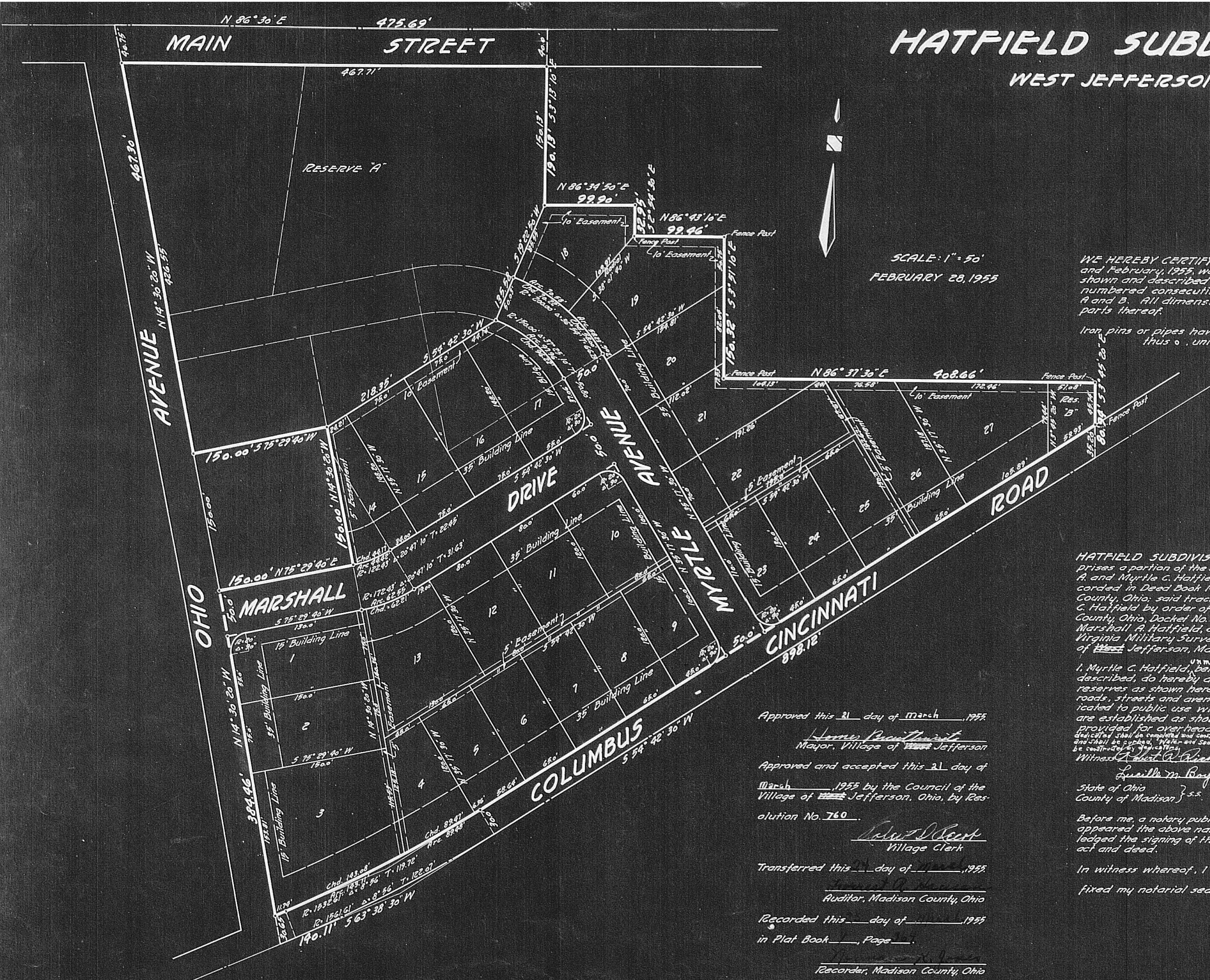

HATFIELD SUBDIVISION, of which this is a correct plat, comprises a portion of the 12.64 acre tract conveyed to Marshall A. and Myrtle C. Hatfield by Mary L. Jackson by deed as recorded in Deed Book 140, Page 227, Recorder's Office, Madison County, Ohio; said tract having been transferred to Myrtle C. Hatfield by order of the Court of Common Pleas, Madison County, Ohio, Docket No. 11179, in settlement of the estate of Marshall A. Hatfield, deceased; said tract being part of Virginia Military Survey No. 2836, and located in the Village of ~~West~~ Jefferson, Madison County, Ohio.

I, Myrtle C. Hatfield, being sole owner of the property above described, do hereby adapt this subdivision into lots and reserves as shown hereon, and dedicate to public use all roads, streets and avenues shown hereon not heretofore dedicated to public use within the limits shown. Building lines are established as shown hereon. Easements are hereby provided for overhead and underground utilities. All such dedications shall be completed and construed according to specifications of the Village of ~~West~~ Jefferson and shall be subject to Water and Sewer and Storm sewer lines to service said Hatfield Subdivision as constructed or to be constructed.
