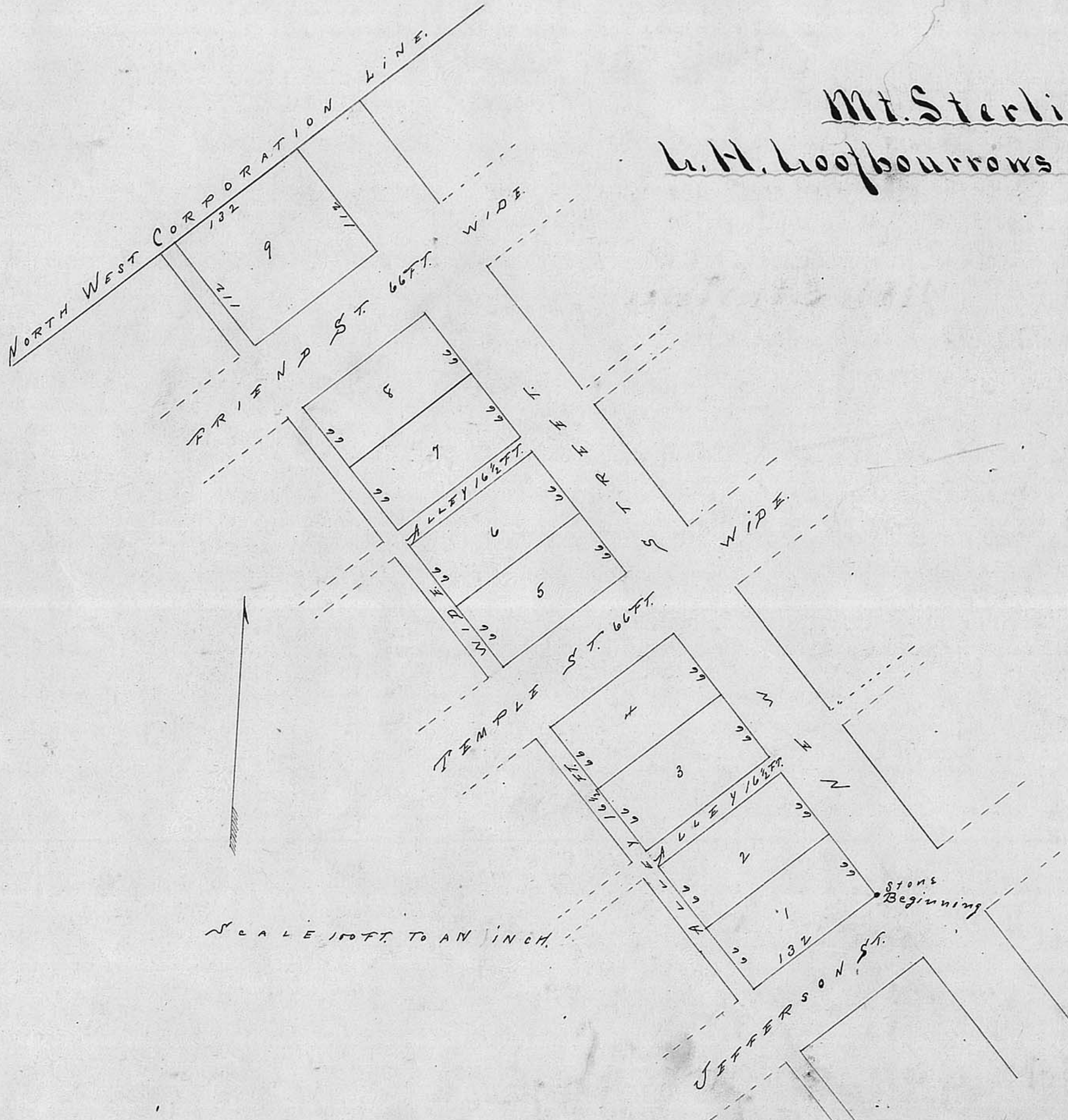


Mt. Sterling.

L.H. Loofbourns, Second Addition

Surveyed for L.H. Loofbourn an addition to the Village of Mt Sterling Ohio to be known as L.H. Loofbourns Second addition to the Village of Mt Sterling Madison County Ohio. This Survey begins at a stone planted at the intersection of the N.W. line of Jefferson Street and the S.W. line of New Street and at the South East corner of Lot No 1. Thence with the S.W. line of New Street N41°30'W 805 ft to the N.W. line of said Village to a stake. Thence with said Corporation line S48°30'W 148 1/2 ft to a stake. Thence with the South West line of an alley S41°30'E 805 ft to a stake in the N.W. line of said Jefferson St. Thence with said line of Jefferson St N48°30'E 148 1/2 ft to the beginning, containing 2.744 acres of land and being a part of Charles Scott's Survey Nos 6483 and 6945. Said addition is laid out into Lots, Streets and Alleys as represented by the above plat. Lots Nos 1, 2, 3, 4, 5, 6, 7, & 8 are each laid out 66 by 132 feet. Lot No 9 is laid out 112 by 132 ft. The Streets are 66 ft and alleys 16 1/2 ft wide. Jefferson & New Streets belong to a former addition and are not included in this survey. The amount of land contained in the streets and alleys included in this addition and herein dedicated to the Public for Public use is 128 3/4 poles. J.L. McCafferty Surveyor, July 23rd 1889.
