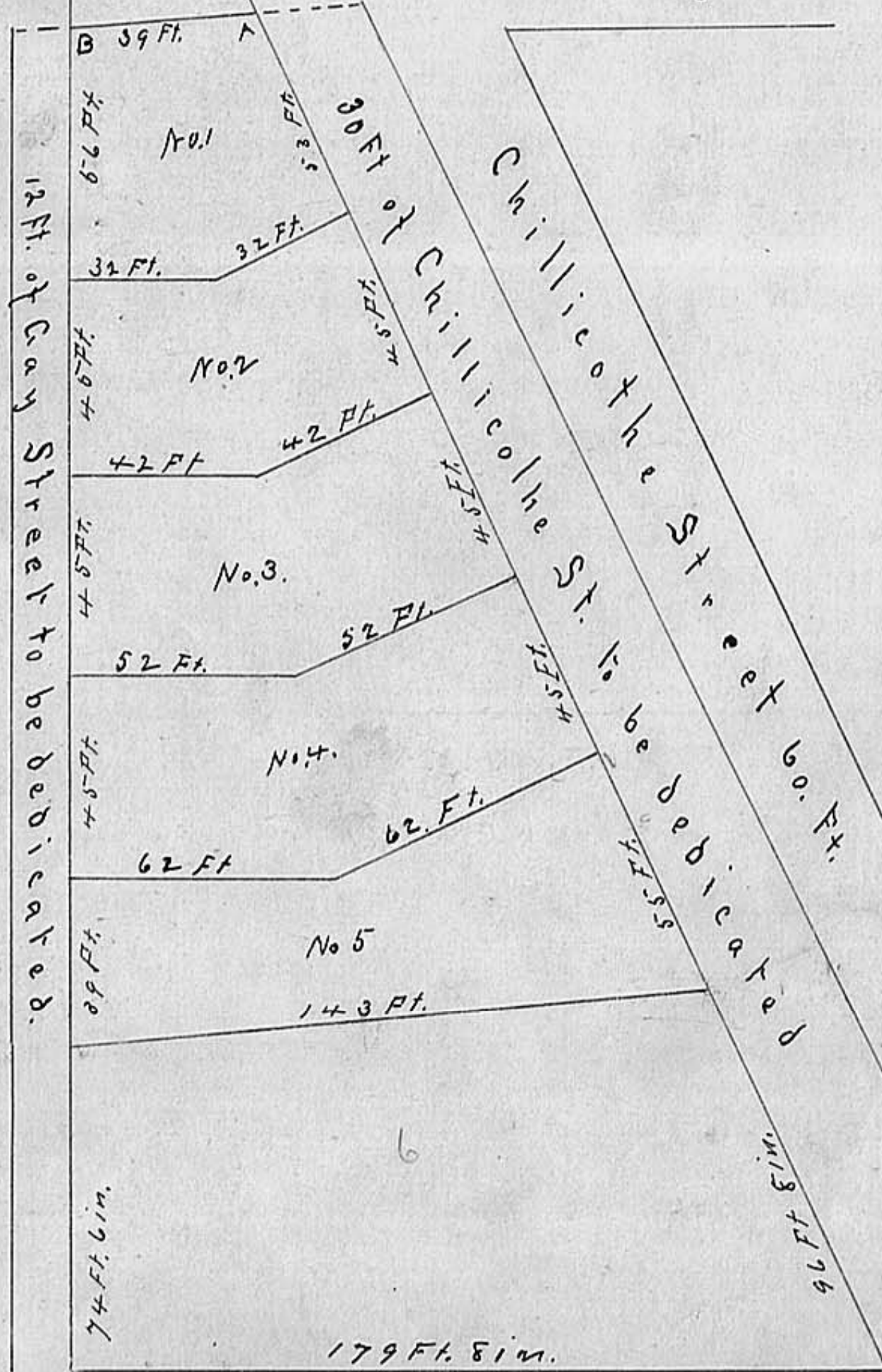

B.H. Marshall's Addition.

B.H. Marshall's Addition to Plain City Ohio. Said addition is predicated upon an Iron pin at A. + B. (see Plat) and Iron pin at A is driven at the N. E. corner of Lot No 1 of this addition and in the west line of Chillicothe Street from A on the west line of Chillicothe Street Lot No 1 is 53 feet at a right angle from this point the South line of said Lot is 32 feet to a stone. Lot No 2 is 45 feet fronting Chillicothe Street the right angle at 45 feet. and S line of said Lot is 42 feet to a stone. Lot No 3 fronting Chillicothe Street is 45 feet a right angle at 45 feet and the South line of said Lot is 52 feet to a stone. Lot No 4 is 45 feet fronting Chillicothe Street a right angle at 45 feet is 62 feet to a stone. Lot No 5 is 55 feet fronting Chillicothe Street at 55 feet the line is S 87° W 143 feet to the East line of Gay Street. the entire length of the South line of Lot No 5 and the entire length of the North line of Lot No 6. Lot No 6 fronting Chillicothe Street is 96 ft 8 inches the South line of said Lot is N 87° W 179 feet and 8 inches to the E line of Gay Street. B. is an iron pin driven in the ground at the N. W. corner of Lot No one of this addition and in E line of Gay Street. Lot No 1 fronting Gay Street is 56 feet the right angle at this point is 32 feet to a stone intersecting the line from Chillicothe Lot. No 2 fronting Gay Street is 45 feet. the right angle at this point is 42 feet to a stone intersecting the line from Chillicothe Street. Lot No 3 fronting Gay Street is 45 feet the right angle at this point is 52 feet to a stone intersecting the line from Chillicothe Street. Lot No 4 fronting Gay Street is 45 feet. the right angle at this point is 62 feet to a stone intersecting the line from Chillicothe Street. Lot No 5 fronting Gay Street is 59 feet. the South line of this Lot has already been described Lot No 6. fronting Gay Street is 76 feet and 6 inches the South line of this Lot has been described.
