Description of Land Surveyed for W. D. Moor.

Beginning at a stone, the N. E. corner of Levi Counts addition to the Village of Midway, Madison County, Ohio; Thence with the E. line of said addition S. 0 degrees and 30 minutes W. 657 feet to a stone, the S. E. corner of said Counts addition; Thence East 330.5 feet to a stone, being the S. E. corner of what now becomes W. D. Moor's addition to the Village of Midway; Thence with the East line of said Moor's Addition N. 0 degrees and 30 minutes E. 657 feet to a stake, the N. E. corner of said Moor's addition; Thence N. 89 degrees and 50 minutes W. 330.5 feet to the beginning, containing five acres of land, being part of Survey No. 7263-7799-5060 in Midway Corporation.

W. D. Moor's Addition.

This addition to the Village of Midway, Madison County, Ohio, consists of the above described tract of land, which is subdivided into sixteen lots with streets and alleys as shown on the accompanying plat and is predicated on four stones located as shown by the letters A-B-C-D. A is at the N. E. corner of Lot 48, and B is at the S. E. corner of Lot No. 41 in Levi Counts addition. All Lots are 66 feet by 132 feet. Center street is 50 feet wide and is parallel to Main street in said Counts addition; Broad street is 66 feet wide and is a continuation of said street in said Counts addition; South or Church street is a continuation of said street in said Counts addition and of this street the proprietor gives 30 feet. All alleys are 16.5 feet wide and are laid off parallel to the streets.

Area of Lots, 3.20 Acres, Area of Streets and Alleys 1.80 Acres.

I hereby certify the above to be correct as surveyed by me, November 6th, 1907.
