

# LONDON

Myers. Addition

This addition is predicated upon the stones (with holes drilled in the tops): planted one at the intersection of Maple and High Streets and the west line of Preston, Adair and the intersection of the center line of said High St. and the other at the intersection of the center line of Maple and First Street. The distance from the stone planted at the intersection of Maple and High Streets and the stone at the intersection of Adairs West line with the center line of said High Street is 760.5 feet, and from the intersection of the center lines of Maple and High Streets to the intersection of the center lines of Maple and First Streets. The distance is 708 feet. The Streets and Alleys run North and South and East and West and of the following widths. Alder Street runs North and South from High Street to Madison Avenue and is forty feet wide. Washington Avenue runs from Maple Street East and parallel with High Street and is sixty feet wide and Madison Avenue runs East from Maple Street and parallel with High Street and Washington Avenue and is sixty three feet wide. All alleys running north and south are each 14 feet wide and alleys running East and West are each  $16\frac{2}{3}$  feet wide. Lots No 3, 4, 5, 6, 7, 12, 13, 14, 15, 16, 21, 22, 23, 24, 29, 30, 31, and 32 are each 66 by one hundred and thirty six feet 37.38.39 & 40 are each 66 ft by 133 feet No 8, 17, 9, 25, 43 & are each 70 ft by 136 ft. 18 is 72 ft by 136 ft. 19 is 68.75 ft on Maple St & 174 ft on Washington Avenue and 68 ft on back alley. 20 is 68.75 ft on Maple Street 164 ft on north line and 68 ft on alley. 36. is 67.5 ft on Maple St and 97 ft on South line and 66.5 ft on alley. 35 is 67.5 ft on Maple St 118.75 ft on Madison Avenue and 66.5 ft on alley. 28 is 68.75 ft on Maple St. 129 ft on Madison Avenue, and 68 ft on alley. 27 is 68.75 ft on Maple St and 151 ft on North line. 11 is 68.75 ft on Maple St 119 ft on Washington Avenue and 68 ft on alley. 10 is 68.75 on Maple Street 141 ft on north line and 68 ft on alley. 1 is 90 ft on High and 137.5 ft on Maple and 68 feet on alley. No 2. is 76 feet by 136 feet. 26 is 72.2 ft by 136 ft. 34 is 74 ft by 136 ft. 42 is 74.2 ft by 133 ft and 41 is 70 ft by 133 ft. Know all men by these presents. That we, Amos C. Myers & Eliza L. Myers his wife of the County of Adams and State of Pennsylvania have adopted the foregoing plat and description of lots, streets and alleys, caused to be laid out by the said A. C. Myers under the name and title of Myers addition to the village of London, in the Co. of Madison and State of O. and numbered the same for record in the proper office of said Co of Madison and do hereby dedicate to public use the streets and alleys as therein described and laid down, and we do hereby acknowledge the same to be our free act and deed for the uses and purposes therein Express ed. Witness our hands and seals.

Before me the undersigned authority in and for said County and State personally came the above named A.C. Myers, and E.L. Myers his wife and acknowledged the signing & sealing of the foregoing plat and dedication of the streets and alleys to public use to be their voluntary act and deed for the uses & purposes therein Express ed. And the said Eliza L. Myers wife of the said A.C. Myers being examined by me separate and apart from her said husband and the contents of said instrument being by me first made known and explained to her, she then declared that she did voluntarily sign, seal, and acknowledge the same and that she is still satisfied therewith. This 10<sup>th</sup> day of March AD 1876. Given under my hand and seal the day and year last aforesaid Cyrus G. Beals, J.P. Seal, State of Pennsylvania Adams County, U.S.
