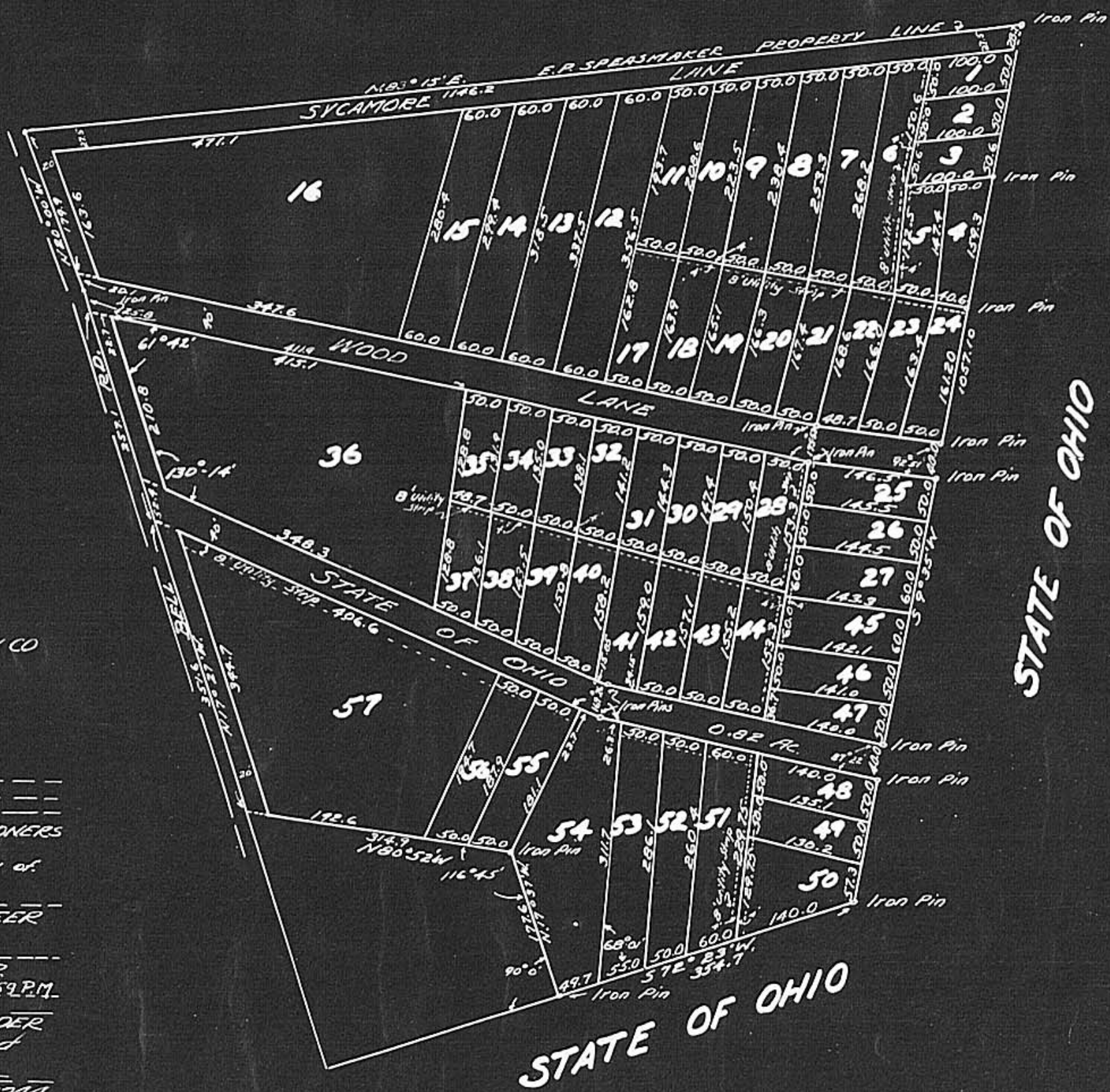




TOM WOOD COLONY A SUBDIVISION

LOCATED IN SURVEY NO 3844 UNION TWP MADISON CO.

Beginning at the intersection of the Spearshaker-Wood property line and the Bell Road thence N63°15'E a distance of 1146.2' to an iron pin on the State of Ohio line, thence S9°35'W a distance of 1057.10 feet to an iron pin, thence S72°23'W a distance of 354.7 feet to an iron pin, thence N17°37'W a distance of 177.6 feet to an iron pin, thence N60°52'W a distance of 314.9' to the Bell Road, thence N17°27'W a distance of 634.5 feet to a point in the Bell Road thence N20°00'W a distance of 200.0' to the place of beginning containing 22.13 Acres more or less, excepting however 0.82 Acres, deeded to State of Ohio leaving a net acreage of 21.31 Acres covered by this subdivision.

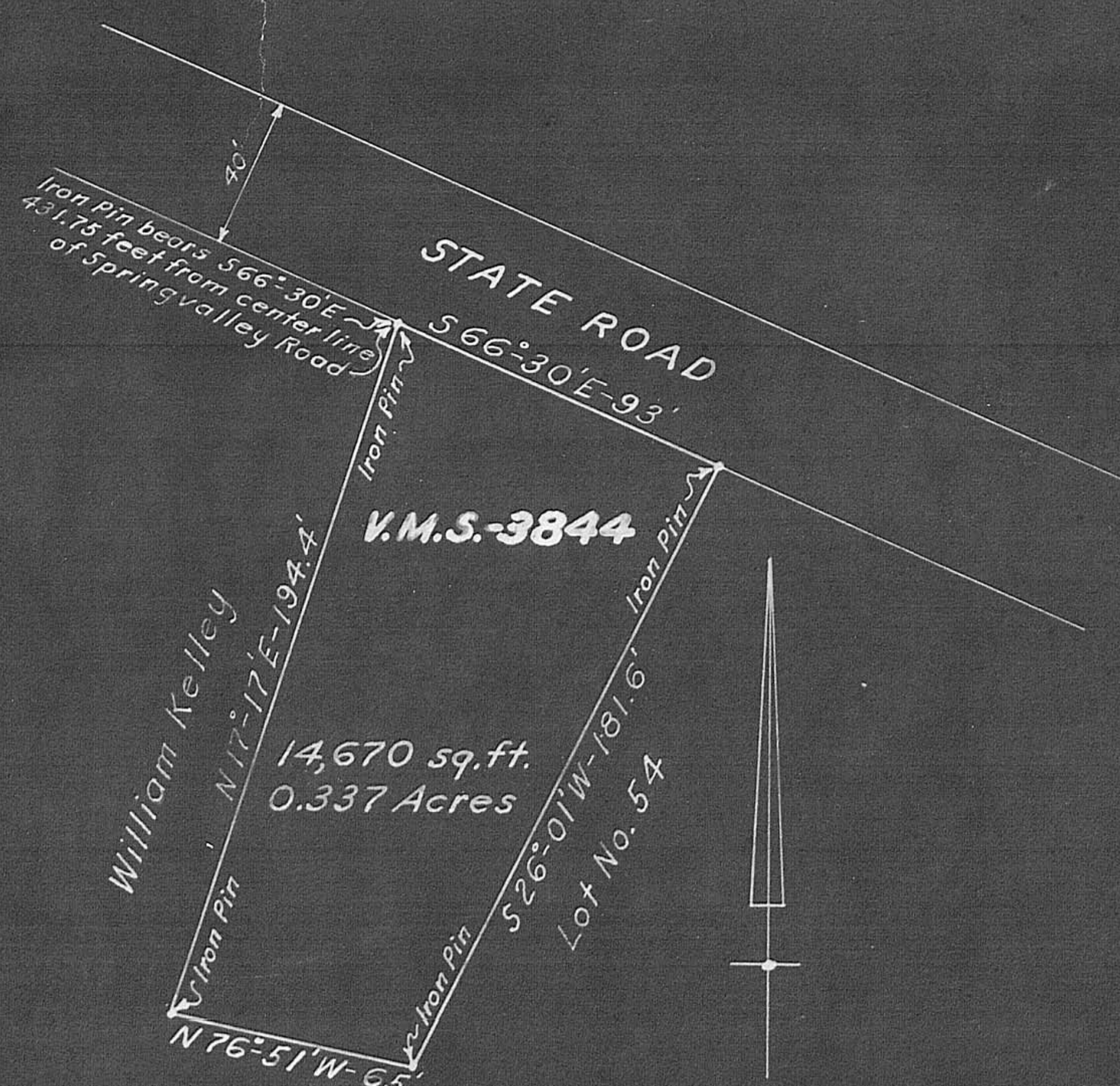
