

P. Webers Second Addition

The above addition to the village of London Madison County Ohio is predicated upon an Iron Stake driven at A a Stone blanted at B and a Stone planted at C. The horizontal distance from A to B is 209 1/2 feet. from B to C is 137 1/4 ft and from A to C is 220 1/5 ft. The bearing and distance of said addition are as follows. viz. Beginning at an iron Stake at A the Southwesterly corner of Thomas Creamer 0.74 acre tract of Land and in the northwesterly line of Toland Street, thence with said line of Toland St S 33° 30' E 209 1/2 ft to a Stake at B. the northwesterly corner of Lot No 1 in William Watson addition to said Village of London, thence with the northwesterly line of said lot and also with the northwesterly line of Mound Street as extended by the addition. N 42° 25' E 137 1/4 ft to C the northerly corner of said lot and the northwesterly corner of Martin Stokes lot. thence same Course the whole distance 340 ft to a Stake at D in the northeasterly line of Fairview Street thence with said line of Fairview Street S 33° 30' E 80 1/2 ft to a Stake at E. the northwesterly corner of William Shorters lots. thence with the northwesterly line of said Shorters. N 56° 13' E 282 1/2 ft to a Stake at F the Northeasterly corner of said Shorter thence N 33° 30' W 355 1/10 ft to a Stake at G in the southeasterly line of James Dwyers land, thence with said Dwyers line S 42° 50' W (passing a corner of said Dwyers and Thomas Creamer at 282 1/2 ft 631 feet to the beginning and containing 3 acres and 10 4/5 poles of land. The Streets as laid out in the above addition are 50 feet wide and the alleys are 16 feet wide. The bearing and length of each line of each lot is marked on above plat and the quantity of land contained in each lot is marked thereon with red ink Lot No 1 of William Watsons Addition and Toland Street are no part of the above addition.
